On behalf of the Governor of Kerala, Two Cover e-tenders are invited from manufacturers or authorized dealers for Rani Kayal & Chithira Kayal Padasekharam, by the Director of Agriculture for the Supply, Installation, commissioning and trial run inclusive all items required for low head, high discharge vertical axial flow pumps with prime movers whose specifications are given in the annexures. The pump-sets are to be erected in selected sites of Rani Kayal Padasekharam and Chithira Kayal Padasekharam of Alappuzha District.

Cost of e-Tender & E.M.D. (online Payment) :as shown above table all payment including EMD should be made as single payment through online

Date up to which the rates are to remain firm for acceptance: 120 Days days from the date of opening

Performance Security: 5% of total contract amount inclusive of E.M.D which 2.5 % should be in the form of Treasury Fixed Deposit.*

Period of Supply: Within 120 days of receipt of supply order.

The bidder desiring to take part in the bid shall log into https://etenders.kerala.gov.in/ and then select tender and initiate payment. Bidders will be directed to the payment gateway page of the State Bank of India. There are two options – (1) State bank of India

(SBI Net banking payment) and (2) Payment through NEFT from other banks to the payment gateway of SBI.

For obtaining digital signature certificate (DSC) and necessary portal enrolment bidders can visit the website https://etenders.kerala.gov.in/

The e-tenders submitted by the competent manufacturer/authorized dealer should definitely contain a scanned and signed copy of the **Annexure I to IV**of the Pumps and accessories intended for supply.

Tenders will be opened in the online presence of such bidders or their authorized representatives who have logged in at the prescribed time of opening. If the date fixed for opening happens to be a holiday or due to net failure the tenders will be opened in the next working day, at the same time.

Soon on opening the technical bid of e-tenders, tender documents will be evaluated for the technical aspects of the pump & accessories will scrutinize the technical specification of the items submitted. On finalization of the same, the financial bid of the concerned competent firm will be opened for consideration.

The price of the e-tender tender form shall be received only through online payment -SBI / NEFT from other banks.

Scanned copy of the agreement (Annexure III) in the prescribed format in Kerala Stamp paper worth **Rs. 200/- should be submitted online** and original to the undersigned before the opening of the e-tender.

The rates should be quoted in Indian currency only.

Details with respect to the e-tender and the details of specifications of the item to be purchased can be obtained from the e-tender website https://etenders.kerala.gov.in

The committee headed by The State Agricultural Engineer will scrutinize the tenders received and will take necessary action for the award of tender. The decision of the Director of Agriculture will be final for the award of the contract.

The rules and regulations prescribed for e-tenders by the Government of Kerala shall be applicable to this e- tender also.

Special Conditions:

1. The manufacturers / authorised dealers are eligible to participate in the tender and necessary documents are to be produced on demand.

- 2. The rates quoted for the work should be inclusive of all taxes, cesses etc.
- 3. The work should be inclusive of transportation, handling or any other cost of installation/ supply and the firm has to supply and erect the items at the location as specified by the under signed.
- 4. The bidder should confirm the repair & service facilities, availability of spare parts etc., of the items supplied by them.
- 5. A minimum Guarantee period of two year is to be assured for the items supplied AMC for 8 years thereafter should separately mentioned in Annexure IV.
- 6. Authorized test report from competent authority should be attached wherever applicable.
- 7. The Director of Agriculture reserves the right to award the full quantity of supply to any one bidder or distribute the work to different bidders without assigning reasons thereof.
- 8. The bidder should give the details of the nearest service centre and response time.
- 9. The terms of AMC after 10 years (2 Year Grantee Period + 8 Year AMC Period) should be mentioned in annexure II.
- 10. Leaflets/ brochures/catalogues of the item describing its features, applications, specifications etc should be provided along with the technical bid. A declaration in the prescribed format as per Annexure IV must be attached with technical bid.
- 11. A scanned copy of preliminary agreement (Annexure III) signed in Kerala stamp paper worth Rs. 200/- should be uploaded along with tender documents.
- 12. EMD, Cost of Tender form + GST etc. should be made as a single payment through online.
- 13. The successful tenderer will have to execute an agreement in stamp paper worth Rs. 200/- in prescribed form and manner and also to furnish the required security amount @ 5% of total quoted amount up to in which minimum 2.5% should be in the form of treasury fixed deposit within 14 days of the receipt of supply order.
- 14. The payment shall be released only after satisfying the conditions qualities and specifications of the items supplied and its successful installation, commissioning and trial run.

- 16. The work should be completed within 6 months on receipt of the work order.
- 17. Income Tax, GST, KCWWFB contribution, service tax etc... will be deducted in the bill at the rates applicable at the time of making payment.

Any legal disputes that may arise in relation to the e-tender formalities will be restricted to the jurisdiction of Thiruvananthapuram District Court. Communications to be addressed to:
