As per references 1,3,5,7, cited above, 4 fertilizer samples [18:18:18(4nos)] manufactured by your firm were reported non-standard during 2018-19. The explanation furnished by you in this regard, vide references 2,4,6 were not at all satisfactory.

It is further noticed that your !:cense had been suspended for one month during 2016-17 and during 2017-18 vide reference 8 and 9 cited. Despite this, it is seen that you have not cared to comply with the directions in the manufacture of fertilizer mixtures as per FQO specifications, and it invites penal action. Considering the fact that there is grave contravention in the provisions of the Fertilizer Control Order, 1985 in ensuring the quality specifications and adherence to the directions by the

registering authority, it is hereby decided to suspend the certificate of registration issued for manufacture of fertilizers, vide No.4/std.Mix/11-12/R/2017-18 valid up to 18.10.2020, for a further period of 60 days from 29.01. 2019 as per Clause 31 of the said Order.

Continuation of your registration beyond the suspension period shall be subject to the compliance of this order during the suspension period and your undertaking to comply with the quality standards in future, and reccurance of non-standard reports in future will lead to permanent cancellation of the Registration Certificate issued to you.
