As per reference (1) telephone and Internet connections were given to **903 Krishi Bhavans** incurring a total cost of Rs. 56,77,161/- under Special Broadband Plan-BBG FN Combo - 599 for one year during the financial year 2012-2013 under the Plan Scheme, Strengthening of Agricultural Extension - Information support to Krishi Bhavans. During the same period new internet connections were provided to 35 offices including Farms and engineering offices of the Department incurring a total cost of Rs. 2, 20,045/- under the Special *Broadband Plan-BBG FN Combo-599*. As part of this project, Telephone and Internet connections were given to **146 ADA Offices** incurring a total cost of Rs. 9,35 ,130/- under Special Broadband Plan - BBG FN Combo - 599 for one year during 2012-13, under the Plan Scheme, "Strengthening of Agriculture"- IT and Cyber extension".

As per reference (4) read above, Government have issued Administrative Sanction for the implementation of the project proposal regarding the "National e-Governance Plan" to be implemented as new service procedure with a Budget provision of Rs.277.42 Lakhs. As per direction of Government of India, Internet connection of 146 ADA offices was upgraded from Special Broadband Plan-BBG FN Combo-599 to Special Plan BBG ULD Combo-900 during 2013-2014 year, at a cost of Rs.14,55,474/-. The comparison of the two Plans is given below:

As per reference (5) read above Government have approved proposal for providing computer and connectivity to Krishi Bhavans and other offices of the Department of Agriculture. Rs 86,92,968 /- was given to BSNL to meet the cost of internet charges of 872 connections of Krishi Bhavans /farms and other offices except ADA Offices under *Special Plan BBG ULD Combo-900* for a period of one year during 2013-14.

During the transition from Special Broadband Plan BBG Combo-599 to Special Plan BBG ULD Combo-900 Telephone and Internet charges for two months are pending to BSNL as detailed below:

The excess internet usage and telephone calls made by the officers are likely to be reflected in telephone bills and such excess amount are to be paid by the officers concerned, who are responsible for excess usage.

It has been noticed that there is a tendency to not remit the bills for excess usage of internet/telephone calls over and above the limits prescribed by the scheme, and often result in cutting of connections by the BSNL. Hence, it is clarified that the additional bills for excess usage of the telephone/internet over and above the limits prescribed by the Scheme by the officials enjoying the facility and this amount of excess usage incurred will not be reimbursed from Department. However officers can reimburse that excess amount from the allotments from local self government institutions if permitted by them.

During the current year also the excess usage in terms of additional telephone calls have to be paid by the officer in charge of the facility. DDA(T)s are directed to take special care in ensuring payment of dues to BSNL incurred due to excess usage by officers.

The phone numbers and internet connection *under Special Broadband Plan BBG Combo-599* provided during 2012-13 in which payment is not due at present will be paid from the Directorate for continued service and will be upgraded to *Special Plan BBG ULD Combo-900 at the time when* payment becomes due during the future months of the current financial year.

DDA(T)s are directed to prepare a database of all phone numbers in their district in consultation with District level Nodal Officers of BSNL. They are also directed to collect complaints regarding the connectivity and to settle them in consultation with the District level BSNL authorities then and there. Only those completes, which require attention and follow up from the State level need be communicated to the Directorate.

In future, the plan will be finalized at Directorate level and payment and continuous follow up will have to be made from District level to ensure timely action and efficient follow up. The details of contact numbers of the District Level BSNL officials are given below:
