The e-tenders submitted by the competent dealer/supplier should definitely contain a scanned and signed copy of the **declaration of product offered** (Annexure IV) of the machineries and accessories intended for supply.

Tenders will be opened in the online presence of such bidders or their authorized representatives who have logged in at the prescribed time of opening. If the date fixed for opening happens to be a holiday or due to net failure the tenders will be opened in the next working day, at the same time.

Scanned copy of the agreement (Annexure III) in the prescribed format in Kerala Stamp paper worth **Rs. 200/-** should be submitted online and original to the undersigned before the opening of the e-tender.

The rates should be quoted in Indian currency only.

The right of acceptance or rejection of e-tender without assigning any reason is solemnly vested with Office of the Assistant Executive Engineer (Agri.), Kasargod.

Special Conditions:

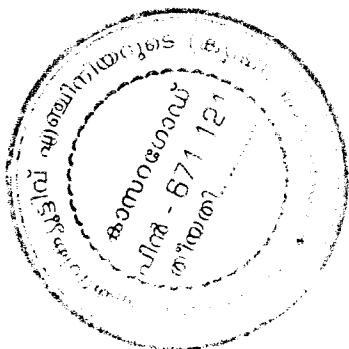
1. Only the manufacturers or their authorised dealers are eligible to participate in the tender and necessary documents are to be produced on demand.
2. The rates quoted should be inclusive of all taxes, cesses etc.
3. The rate should be inclusive of transportation, handling or any other cost of installation/ supply and the firm has to **supply the items at KKS Paivalige KB** or as per the direction from the under signed within Kasaragod District.
4. The supplier should confirm the repair & service facilities, availability of spare parts etc., of the machineries and equipments supplied by them.
5. A minimum warranty period of **One year** is to be assured for the machineries supplied.
6. Authorized test report from competent authority should be attached where ever applicable.
7. The Office of the Assistant Executive Engineer (Agri.), Kasargod reserves the right to award the full quantity of supply to any one supplier or distribute the supply to different suppliers without assigning reasons thereof.
8. A scanned copy of preliminary agreement signed in Kerala stamp paper worth Rs. **200/-** should be uploaded along with tender documents.
9. Cost of Tender form, E.M.D form including GST should be made through **online** only.
10. The successful tenderer will have to execute an agreement in stamp paper worth Rs. 200/- in prescribed form and manner and also to furnish the required security amount @ 5% of total quoted amount including EMD within 14 days of the receipt of selection notice.
11. The payment shall be released only after satisfying the qualities and specifications of the machineries.
12. The Office of the Assistant Executive Engineer (Agri.), Kasargod has the right to accept or reject any tender without assigning any reason whatsoever.

13. Tender received incomplete in any respect will be summarily rejected and the decision of the under signed on such matters will be final.
14. The supply should be completed within fourteen days on receipt of the supply order.
15. The supplier should undertake field demonstration and operators training in the site, if found necessary.
