As per the reference 1st and 2nd cited, Government have accorded Administration Sanction for the implementation of the scheme '**Modernization of Departmental Laboratories**' during 2017-18 for a total amount of Rs. 600 lakh under the Head of account 2401-00-105-86 Plan .

As per the reference 3rd cited, continuous sanction was accorded for implementation of the scheme during 2018-19 for an amount of Rs. 525 lakh under the Head of Account 2401-00-105-86 Plan.

As per the reference 4th cited, continuous sanction has been accorded for implementation of the scheme during 2019-20 for an amount of **Rs. 599.81489 lakh** under the Head of Account 2401-00-105-86 Plan.

Two Bio Fertilizer Laboratories are functioning in the state to make available good quality Bio fertilizers to the farmers at reasonable rate so as to promote organic cultivation of crops.

The targets assigned for production of Azospirillum and VAM during 2019-20 in these laboratories are as follows:

Strengthening of State Bio Fertilizer Laboratories

The strengthening of two existing laboratories include purchase of inert materials like vermiculite, chemicals, purchase of packing material for biofertilizer, repair of laboratory equipments and other miscellaneous requirements.

An amount of **Rs. 6.5 lakh** is provided for the strengthening of these laboratories under the Head of Account **2401-00-105-86 Plan**.

As per reference 4th cited, Chief Soil Chemist has submitted proposal for Rs.6.5 lakh for the various purchases and requirements to be under taken in the above laboratories.

The Officers in charge of the laboratories are responsible for the timely purchase of vermiculite, Polythene covers, repair and maintenance of equipments and other Miscellaneous expenses

The Principal Agricultural officer assisted by the Deputy Director of Agriculture (E&T) will monitor the functioning of the Labs in the Districts. Chief Soil Chemist will co-ordinate the functioning of the labs. Monthly progress reports should be furnished to the Director of Agriculture by the 5th of every month.

Additional Director of Agriculture (Planning) will monitor the scheme at the state level.

The amount of **Rs. 6.5 lakh** set apart for the implementation of this scheme can be met from the funds provided under the Head of Account **2401-00-105-86 Plan**.
