The Budget provision for the scheme 'Soil and Root health management and productivity improvement' for 2020-21 is 2462.00 lakhs. Continuous Administrative Sanction was accorded for the scheme, vide reference (1) cited for Rs. 1243.96601 lakh (Rupees One thousand two hundred and forty three lakh, ninety six thousand six hundred and one only) for the single component 'Soil ameliorants in selected districts' after deducting the amount of Rs.1218.03399 lakh allotted for encashment of bills not e-submitted to treasury upto 31.3.2020 and can be submitted on or before 18/4/2020 and for encashment of 'Queue' bills & WAMS clearance bills of 2019-20 as per circulars from finance section of Government in this regard.

As per reference 2nd cited, continuous administrative sanction for the scheme was revised and accorded for an amount of Rs.1138.82761 lakh on request of the implementing section due to additional allotment required for encashment of Queue bills of 2019-20 under this scheme for Pathanamthitta, Kozhikode, Kannur and Wayanad districts.

Now, as per reference 3rd cited, TF(2) section has reported that as there is error in the allotment requests submitted from their section an amount of Rs.18.83898 lakh was incorrectly allotted to PAO, Alappuzha for encashment of WAMS clearance bills. This amount has been surrendered and resumed from the Principal Agricultural Officer, Alappuzha. The implementing section has also informed that an additional amount of Rs.9.58791 lakh is required for Kollam district for encashing bills under Treasury queue.
