If the date fixed for opening happens to be a holiday or due to net failure the tenders will be opened in the next working day, at the same time and place.

Scanned copy of the preliminary agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/- should be submitted online** and original to the undersigned before the opening of the e-tender.

The rates should be quoted in Indian currency only.

The rules and regulations prescribed for e-tenders by the Government of Kerala shall be applicable to this e- tender also.

#### **Special Conditions:**

1. The manufacturers or their authorised dealers are eligible to participate in the tender and necessary documents are to be produced along with tender.
2. The rate quoted should be inclusive of taxes, cesses, insurance, registration, transportation, handling or any other cost of installation/ supply and the firm has to **supply the items** Agricultural machineries for **Agro Service Centre, Aryancode** or as per the direction from **Office of Assistant Executive Engineer(Agri), Thiruvananthapuram**
3. The supplier should ensure the repair and service facilities, availability of spare parts etc of the machineries and equipments supplied by them, as and when they occur.
4. Tender evaluation will involve recording and analyzing the merits of each tender. The process will start with preparation of comparative Statement based on product offered statement and other documents furnished by bidders, incorporating the commercial terms offered. Comprehensive analysis of techno- commercial offer will form the subsequent decision.
5. The catalogue/ leaflets/ Pamphlets etc of the product offered should be submitted along with the tender.
6. A minimum warranty period of 1 year to be assured for the machineries supplied
7. Authorized test report from competent authority should be attached.
8. The successful bidder will have to execute an agreement in Kerala stamp paper of prescribed value, in the prescribed format and manner and also to furnish a security amount @ 5% of the total quoted amount within 14 days of the receipt of confirmation
9. The payment shall be released only after satisfying the qualities and specifications of the machineries
10. Tender received, incomplete in any respect, will be summarily rejected and the decision of the under signed on such matters will be final.

11. The manufacturer of the quoted machine should have supplied a minimum of ten units in the government sector in Kerala State during last 3 financial year and details of the machine owners shall be uploaded along with dealership certificate and GST certificate.

12. Cancellation of bids for any of the items listed, subjected to availability of funds, is at the sole discretion of undersigned.

Any legal disputes that may arise in relation to this e-tender will be restricted to the jurisdiction of Thiruvananthapuram District Court
