GOVERNMENT ORDER ON THE RECOMMENDATIONS OF THE TENTH PAY REVISION COMMISSION ON REVISION OF PAY AND ALLOWANCES OF STATE GOVERNMENT EMPLOYEES AND TEACHERS

G.O.(P) No.7/2016/Fin. Dated 20/01/2016

Spectacle Allowance

17. The cost incurred towards the purchase of spectacles will be reimbursed subject to a maximum of Rs.1200. Reimbursement will be allowed once in five years.

Footwear allowance

18. The existing rate of Footwear Allowance to eligible categories will be enhanced to Rs.450 per annum as shown in Annexure VII. The eligibility conditions will remain the same.

Special Commando Allowance

- **19.** Special Commando Allowance @ 15% of basic pay will be allowed to special commandos in Police Department irrespective of the rank or branch or the police unit to which they belong. This allowance is subject to the following conditions:
 - **1.** Maximum number of persons eligible for this allowance shall not exceed 60 at a time.
 - **2.** The physical and commando efficiency of individuals enjoying this allowance should be assessed annually by a competent board appointed for the purpose and list of commandos eligible for this allowance should be published by the appropriate authority.
 - **3.** The standard and training of commandos should be continuously monitored.
 - **4.** The allowance shall be discontinued to those who are found not satisfactory in maintaining the required standards.
 - **5.** Fresh personnel who pass the test and undergo competent training should be taken into the commando Platoon to replace those who cease to be commandos.

Training Allowance

20. The revised rates of Training Allowance payable to officers of the Police Training College, Thiruvananthapuram and Kerala Police Academy, Thrissur will be as follows:

ORDER

As per the Government Order read as 2nd above, pay and allowances of State Government Employees, Teachers and Part Time Contingent Employees have been revised w.e.f 01.07.2014 wherein it has been ordered that the cost incurred towards the purchase of spectacles will be reimbursed subject to a maximum of Rs.1200/- and the benefit will be admissible once in five year of service. But this benefit has not been extended to Part Time Contingent Employees.

2. Government have examined the matter in detail and are pleased to order that Part Time Contingent Employees will be allowed to reimburse the cost towards the purchase of spectacles for own use subject to a maximum of Rs.1200/- as per the procedure laid down in G.O read as 1st above. The reimbursement will be allowed once in five year of service.

ORDER

As per Rule 3 (F) of the Kerala Government Servants Medical Attendance Rules, 1960, "Spectacles" is not a reimbursable item. In Government Order read 1st paper as above, this rule was relaxed to the extent that the reimbursement of cost of Spectacles purchased by Government Servants for their own use was enhanced to a maximum of 100. The claims has to be supported by the Bills showing the cost of Spectacles purchased and Essentiality Certificate issued by the Authorised Medical Attendant. This benefit was limited to the Government Servants only once during the entire period of their service and a certificate, to that effect has to be recorded in the Service Book of the concerned Government Employee by the respective controlling officers.

- 2. In Government Order 2nd read above the reimbursement of the cost of Spectacles purchased was enhanced to ₹ 1000, which can be claimed once in 10 year of Service.
- 3. In order to simplify the procedure and for the speedy settlement of claim Government hereby order that the cost of spectacles purchased for own use of Government Servant will be reimbursed on the strength of the self certification by the Government employee concerned, in the original bill of purchase of spectacles with entries in Service Book by the controlling officers.
- 4. Formal amendment to the KGSMA Rules, 1960 will be issued separately.
