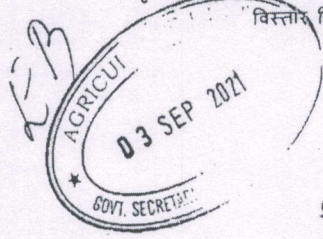

Subject-Filling up of One (01) vacancy of Assistant Editor (Hindi) in the Level 7 (Rs.44900-142400), in the Directorate of Extension by composite method deputation plus promotion - regarding.

The undersigned is directed to say that One (01) vacancy of Assistant Editor (Hindi) in the Level 7 (Rs.44900-142400), (Pre-revised PB-2 9300-34800+4600GP) (Group 'B') (Gazetted) (Non-Ministerial) in the Directorate of Extension, Ministry of Agriculture & Farmers Welfare, Department of Agriculture & Farmers Welfare, New Delhi, is required to be filled up by composite method deputation plus promotion.

Deputation Plus Promotion:

Officers Under the Central Government or State Government or Union Territories:-

- (A) (i) holding analogous post on regular basis in the parent cadre or department;  
or  
(ii) with a five years regular service in the grade rendered after appointment thereto on a regular basis in the Level 6 or equivalent in the parent cadre or department and
- (B) Possessing the educational qualifications and experience prescribed as under:
- (a) Essential:
- (i) B.Sc in agriculture from a recognized University with Hindi as a subject upto 12<sup>th</sup> level in 10+2 system.
- (ii) Two year experience of writing or editing or compiling articles in Hindi on topics related to Agriculture or in Audio Visual presentations or exhibitions in Hindi medium on topics related to Agriculture.
- (b) Desirable:
- (i) Diploma in Journalism from a recognized University or Institute or equivalent
- (ii) M.Sc. in Agriculture or Agricultural Extension from a recognized University or Institute.

Note 1: The Departmental Sub-Editor (Hindi) with five years' regular service in the grade in Level 6 (Rs. 35400-112400) shall also be considered along with outsiders and in case he or she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 2: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation (including short-term contract). Similarly, deputation shall not be eligible for consideration for appointment by promotion.

[Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date for receipt of applications.]



**Note 3:** For the purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised grade pay with a common level in pay matrix, and where this benefit will extend only for the post(s) for which that level of pay matrix is the normal replacement level without any up-gradation.

The selected officer will have the option either to draw his grade pay plus deputation (duty) allowance in accordance with the Ministry of Finance instructions issued from time to time or gets his pay fixed in the scale of pay of the post in accordance with the normal duties.

It is requested that the vacancy may kindly be accorded due publicity and the applications, with details of service particulars in the enclosed pro-forma as per Annexure from suitable and willing Officials, along with duly attested photocopies of ACRs/APARs for the last 5 years, may kindly be forwarded to the undersigned, by name within 60 days from the date of publication of this advertisement in the Employment News/Rozgar Samachar.

While forwarding the applications, it may also please be verified and certified that the particulars furnished by the applicant are correct and that no vigilance proceedings are pending or being contemplated against the officer. The integrity of the Officials may also be certified. It may also please be made clear that in the event of selection, the candidate will not be allowed to withdraw his/her candidature and will be relieved immediately.
