

Officers Under the Central Government or State Government or Union Territories:-

- (A) (i) holding analogous post on regular basis in the parent cadre or department;
  - (ii) with a five years regular service in the grade rendered after appointment thereto on a regular basis in the Level 6 or equivalent in the parent cadre or department and
- Possessing the educational qualifications and experience prescribed as under:
  - (a) Essential:
    - (i) B.Sc in agriculture from a recognized University with Hindi as a subject upto 12th level in 10+2
    - (ii) Two year experience of writing or editing or compiling articles in Hindi on topics related to Agriculture or in Audio Visual presentations or exhibitions in Hindi medium on topics related to Agriculture.
  - (b) Desirable:
    - (i) Diploma in Journalism from a recognized University or Institute or equivalent
    - (ii) M.Sc. in Agriculture or Agricultural Extension from a recognized University or Institute.

Note 1: The Departmental Sub-Editor (Hindi) with five years' regular service in the grade in Level 6 (Rs. 35400-112400) shall also be considered along with outsiders and in case he or she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 2: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation (including short-term contract). Similarly, deputation shall not be eligible for consideration for appointment by promotion.

[Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date for receipt of applications.]

Note 3: For the purposes of appointment on deputation hasis, the service rendered on a regular basis by an office prior to 1st January, 2016 or the date fro n which the revised pay structure based on the Seventh Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the Commission except where there has been merger of more than one prerevised grade pay with a common level in pay matrix, and where this benefit will extend only for the post(s) for which that level of pay matrix is the normal replacement level without any up-gradation.

The selected officer will have the option either to draw h s grade pay plus deputation (duty) allowance in accordance with the Ministry of Finance instructions issued from time to time or gets his pay fixed in the scale of pay of the post in accordance with the normal duties.

It is requested that the vacancy may kindly be accorded due publicity and the applications, with details of service particulars in the enclosed pro-forma as per Annexure from suitable and willing Officials, along with duly attested photocopies of ACRs/APARs for the last 5 years, may kindly be forwarded to the undersigned, by name within 60 days from the date of publication of this ad ertisement in the Employment News/Rozgar
