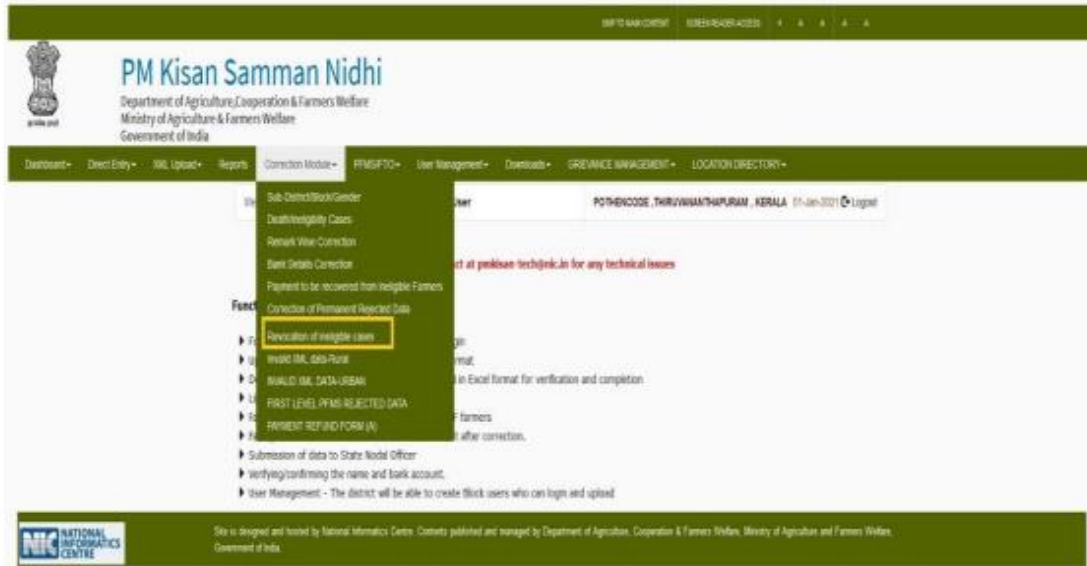


II. Revocation of Ineligible case - Instruction and Steps

Step 1.

Log in to your account > correction module > Revoke ineligible farmer.



Step 2:

Enter the Aadhaar number /Account number / Mobile number of the farmer.
Select the reason for revoke.

- In the upload option, a request letter from ADA on recommendation through Agricultural officer is to be uploaded, also note the letter should be in English. The revoke should be informed to the PAO as and then.
- A list of revoked farmers should be maintained in a register or a physical file should be kept in the Krishibhavan with all the details.
