ORDER

As per the Government Order read as first paper above sanction has been accorded to the Director of Agriculture for releasing an amount of Rs.30 lakhs for the disbursement of salary and wages to the employees working in IRTCBSF. As per letter read above, the Director, International Research and Training Centre for Below Sea Level Farming has reported that the same amount is not sufficient for meeting the above expenses. Hence requested to sanction an amount of Rs. 40 lakhs for meeting the expenditure of salary and other expenditure.

2) As per Government Order read as third paper above has authorised an amount of Rs. 10 lakhs as additional expenditure under the H/A 2415-01-004-88 (Plan) for the disbursement of salary and wages to the employees working in International Research and Training Centre for Below Sea Level Farming, (IRTCBSF), Kuttanad.

3)Government have examined the matter in detail and are pleased to accord sanction to the Director of Agriculture to release an amount of Rs.10,00,000/- (Rupees Ten Lakh only) from the H/A 2415-

01-004-88 (Plan) to the PSTSB Account No. 799012700001387 (Sub Treasury, Ambalapuzha) of the Director , IRTCBSF for the disbursement of salary and wages to the employees working in International Research and Training Centre for Below Sea Level Farming , Kuttanad (IRTCBSF).

4) The Director of Agriculture will take necessary steps to regularize this additional expenditure through re-appropriation of savings only within the Grant before the close of the current financial year.
