- 3. The rates to be quoted online by using BOQ form in excel format published in the web site https://etenders.kerala.gov.in. Price documents submitted through any other mode will not be accepted.
- 4. The undersigned is at liberty to test and satisfy the quality of the item supplied and the supplier is liable to replace any item demanded during such testing at his cost. If the quality /grade of any of the items are found not adhered to the specified quality/grade, he will be blacklisted for participating in tender processes of the Agriculture Development and Farmers' Welfare Department in future.
- 5. The undersigned reserves the authority to accept or reject any or all of the offers for any particular item without assigning any reason whatsoever.
- 6. The Bidder or his agent should be present at the time of supply of Chemicals and should entrust the officers concerned at various Soil Testing Laboratories mentioned in the supply order.
- 7. Violation of any rules/special conditions /directions of supply order by the supplier will lead to rejection of his bid. The materials should be supplied within the stipulated time as in the tender conditions and any delay in this regard from the part of the supplier will be considered as the violation of the conditions. A specific percentage of the total payment to the supplier will be forfeited for the delay of each month or part thereof.
- 8. On completion of the supply as per the contract, the invoice in triplicate should be drawn in favour of the Chief Soil Chemist or

the Assistant Soil Chemist concerned as per the list in the supply order for effecting payment.

- 9. In case of any disputes the decisions of the Director, Agriculture Development & Farmers' Welfare Department, Vikas Bhavan, Thiruvananthapuram, Kerala 695033 shall be the final.
- 10. All terms and conditions governing the purchase of stores by the Government of Kerala will apply in this case also.
