## **ORDER**

As per the letter read as third paper above, Government of India have communicated allocation of Rs. 6101 lakhs (Rupees Six thousand one hundred and one lakh only) as Central share for Kerala under Rashtriya Krishi VikasYojana- (RKVY) during the financial year 2022-2023 .

2. As per the Government Order read as 4<sup>th</sup> paper above,the 1<sup>St</sup> instalment funds of Rs.1993.33 lakhs for Normal RKVY (General ) ,Rs. 283.33 lakhs for SCP category &Rs.46.67 lakhs for TSP category was released as Central share & state share under the Rashtriya Krishi Vikas Yojana

- (RKVY) for implementing the new & revalidated projects in the State during the financial year 2022-23.
- 3.As per the letter read as 5 <sup>th</sup> paper above ,Government of India have released the 2<sup>nd i</sup>nstalment of Rs.1196lakhs for Normal RKVY (General) Rs.170 lakhs for SCP category & Rs. 28 lakhs under TSP category as Central share of Rashtriya Krishi Vikas Yojana (RKVY) for the State during the financial year 2022-23.
- 4. The amount released as per reference (6) cited was not drawn from the treasury during 2022-23. Hence the Director of Agriculture has requested to release the second instalment funds of RKVY 2022-23 as sufficient funds are available in the budget provisions of 2023-24.
- 5.Government have examined the matter in detail and are pleased to accord sanction for the release of second instalment funds of 2022-23 for Rs. 2323.33lakhs during 2023-24 for implementing the RKVY-RAFTAAR scheme as detailed in the table below through the Expenditure Advance &Transfer (EAT)module under the revised PFMS-SNA system.
