Officers of the Central/State Government/Union Territories/Public Undertakings/ Autonomous/Semi Government or Statuary Organizations and National Level Cooperative Federations etc possessing the following service, educational qualifications and experience, are eligible:-

Service: - (i) holding analogous post on regular basis; or (ii) with 5 years regular service in the post in the scale of Rs. 12000-16500/- (pre-revised).

Educational Qualifications and experience: - (i) Masters degree of a recognized University or equivalent;

(ii) 12 years experience in the field of Cooperation/Credit in a Government or Cooperation/Credit organization.

Note-I: - The departmental Director (Cooperation/Credit) with 5 years regular service in the grade shall also be considered along with deputationists and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion. The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

- Note-II:- Period of deputation including period of deputation in an inequence post held immediately preceding this appointment in the same or some organization/department of the Central Government shall ordinarily not to exceed 5 to years. The maximum age limit for appointment by transfer on deputation (including shown term contract)/transfer shall be, not exceeding 56 years, as on the closing date of receipt of applications.
- The officers selected on deputation basis, will have the option to draw his grade pay plus deputation (duty) allowance or to have his pay fixed in the scale of pay pay of the post in accordance with DoP&T's OM No. 2/8/97-Estt (Pay II) dated 11.3.1998, as amended from time to time.
