

General Central Service, Group 'A' Gazetted, Non-Ministerial in the pay band of Rs.37400-67000/- plus grade pay of Rs. 8700/- on Composite method Deputation (including Short Term Contract) plus promotion.

Eligibility:-

- 1. Officers under the Central/State Governments/Union Territories/Agricultural Universities/Recognised research Institutions/Autonomous Organisations /Semi Government Organisations/ Public Sector Undertakings;
 - (a) (i) holding analogous post on regular basis in the parent cadre or Department; or

(ii)with five years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 12000-16500(pre-revised) or equivalent in the parent cadre/department; and

(b) Possessing the educational qualifications and experience as under

- (iii) M.Sc (Agriculture) from a recognised University or equivalent
- (iv) Ten years experience in the field of Seed Production/Seed Marketing/Seed Certification/Seed Testing/Seed Quality Control/Seed Development Programmes.

Ph. D in the field of Seed Production/Seed Marketing/Seed Certification/Seed Testing/Seed Quality Control.

Note $1\,:\,$ Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidate otherwise well qualified.

Note 2: The qualifications regarding experience are relaxable at the discretion of the Union Public Service Commission in the case candidates belonging to the Scheduled Castes of the Scheduled Tribes, if at any stage of selection the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities are not likely to be available to fill up the vacancies reserved for them.

The Departmental Seed Technologist/Chief Seed Analyst in the scale of pay of Rs. 12000-16500(pre-revised) with five year service shall also be considered along with deputationists and in case he is selected the post shall be deemed to have been filled by promotion.

The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.

Similarly deputationist shall not be eligible for consideration for appointment by promotion.

Period of deputation (including short term contract) including deputation (including short term contract)in another ex-cadre post immediately preceding this appointment in the same or some other organisation/Department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of application.

The officer selected on deputation basis will have the option to draw his grade pay plus deputation duty allowance as to have his/her pay fixed in the scale of the post in accordance with DOPT's O.M. No.2/8/1997 Estt(Part.II) dated 11.3.1998 as amended from time to time.
