I am directed to say that it is proposed to circulate four vacancies (One vacant post +Two newly created posts and one anticipatory vacant post) in the grade of Regional Director in the scale of Pay Band- 3 Rs.15600-39100 with Grade Pay of Rs.7600/- (General Central Service, Group 'A', Gazetted, Non-Ministerial) in the National Centre of Organic Farming, Ghaziabad, a subordinate office under the Department of Agriculture & Cooperation for filling up by Deputation Including Short Term Contract /promotion. The officers selected can be posted at NCOF, Ghaziabad and its six RCOFs situated at Bhubaneswar, Nagpur, Banglore, Jabalpur, Hissar and Imphal. The posts are to be filled from amongst the officers under the Central Government or State Governments or Union Territories or Universities or Recognized Research Institutions or Public Sector Undertakings or Semi Government or Autonomous or Statutory Organizations, holding analogous posts on regular basis in the parent cadre or department; or having five years regular service in the grade rendered after appointment thereto on a regular basis in the pay scale of Rs. Rs.15600-39,100 with Grade Pay of Rs.6600/- or equivalent in the parent cadre or department; and possessing the following educational qualifications and experience, namely:-

M. Sc. in Botany with specialization in Plant Pathology or Microbiology or Mycology from a recognized university or institutes;

- M. Sc. in Agriculture with specialization in Soil Science or Agricultural Chemistry or Agronomy or Microbiology or Plant pathology or Horticulture or Agricultural Extension from a recognized university or institutes, and
- (ii) possessing ten years experience in the field of research and development of bio-fertilizer and other aspects of organic farming including two years administrative experience.

Desirable

- Ph. D in any of the subject specified in the essential qualifications above from a recognized university or institutes.
- 2. The Departmental Deputy Director (Training) in the Pay Band-3 in the pay scale of rs. 15600-39100 with Grade pay of Rs. 6600 with five years regular service shall also be considered along with outsiders and if selected for appointment, the post shall be deemed to have been filled by promotion.
- 3. The Departmental officers in feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation including short term contract. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- 4. The period of deputation including short term contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed four years.
- 5. The maximum age limit for appointment by deputation including short term contract shall not be exceeding fifty-six years as on the closing date of receipt of application.
- 6. The pay of the officer selected for appointment on deputation basis will be regulated in terms of DOPT's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.

- 7. It is requested that applications (in triplicate) in the enclosed proforma (Annexure-I and Annexure-II), along with copies of complete and up to date last five year CR dossiers(2006-07 to 2010-11), attested by an officer not below the rank of Under Secretary, of the eligible officers who could be spared in the event of their selection may please be forwarded to the Section Officer (INM), Room No, 588, Department of Agriculture and Cooperation, Ministry of Agriculture, Krishi Bhawan, New Delhi immediately and in any case within 60 days from the date of publication of this vacancy in the Employment News.
- 8. Applications received after the last date or otherwise found incomplete or without Confidential Reports will not be considered.
- 9. While forwarding the applications, it may be verified and certified by the sponsoring officer that the particulars furnished by the officers are correct, that no disciplinary case is either pending or contemplated against the officers and that no major/minor penalty was imposed on the officer during the last 10 years. The integrity of the officer may also be certified and cadre clearance may intimated. The applicant shall not be allowed to withdraw his candidature in the event of his selection to the post of Regional Director, NCOF, Ghaziabad.
