

**CIRCULAR**

Sub:New proposal for Crop Rehabilitation in connection with Flood 2018-Scheme on Rodent Control and Plant Protection Measures 2018-19-Working instruction for implementation-Orders issued-reg

Ref: 1) G.O.(Ms)No.147/2018/Agri dated 15/12/2018 of Agriculture(PB)Department  
2) Endt No.TP(2)35268/2018 dated 3/01/2019

Administrative sanction has been received for implementation of a received package-Crop rehabilitation, as less that occurred in agriculture sector is of massive scale due to recent flood and has put a heavy financial burden to farmers as well as the state for restoration/rehabilitation activities. One of the fallout of the recent floods is the outbreak of pest and diseases in many crops. Also rodents have multiplied in many places affecting health of people and damaging crops.

An amount of Rs.125lakhs is earmarked for conducting 500nos of rodent control campaigns throughout the state. It should be conducted on a campaign mode covering the whole area(say panchayath/muncipal wards etc). Vide publicity should be given for the programme and rodent control camapign should be arranged with the involment of all localself government institutions, government and non government institutions, and agencies, peoples representatives, public organizations, farmer organizations etc of the area.

Rs.25,000/- is earmarked for each rodent control camapign for the following activities.
