Administrative sanction has been received for the implementation of Reprioritized Annual Plan Schemes for 2018-19. As a part of revival package, in order to overcome the crisis of massive loss that occurred in agriculture sector due to the recent flood and to support for the financial burden on the farmers as well as the state for restoration/rehabilitation activities and to attain self sufficiency in vegetable production to the maximum possible extent, 22 lakhs seedkits @ Rs. 10/- per kit are proposed to supply free of cost to farmers, homesteads and institutions. The total amount required for this purpose comes to Rs.2.2 crores (Rupees Two crores and twenty lakhs only).

Objectives:-

To overcome the crisis of massive loss that occurred in agriculture sector due to the recent flood and to support for the financial burden on the farmers as well as the state for restoration/rehabilitation activities
