## **CIRCULAR**

Sub: - Annual Plan 2018-19 - Scheme on Strengthening of Agricultural Extension-Information Technology and Cyber Extension - Working Instruction issued - Reg

Ref:- i). G.O.(MS) No.102/2017/AGRI dated 10.8.2017 of Agriculture (Planning - A) Department.

ii). Order No-.TP(2)7462/2018Dated 28-04-2018 of The Director of Agriculture.

As per references cited above, Government have accorded sanction for the implementation of "Information Technology and Cyber Extension" as a part of the "Scheme on Strengthening of Agricultural Extension" under the Head of Account "2401-00-109-80 Plan.

The scheme envisages access to information and improved communication for sustainable agricultural development. For achieving this, modern communication technologies can be utilized for disseminating information and sharing knowledge and skill among farmers. Cyber Extension is considered as one of the new and effective mechanism to promote Agricultural Extension and disseminate scientific technology in field conditions.

To strengthen the existing facilities and start new Cyber Extension efforts, following activities are proposed during the current year.

- 1. Up gradation, repair and procurement of accessories and consumables for existing computers based on actual needs.
- 2. Maintenance of Department website and applications Development. Conversion of present HTML to Content Management Framework and expenses related to hosting website, security auditing of various applications of Agriculture Department.
- 3. Establishment of Cyber Extension Centers in Five Computer Labs of the Department where the internet connectivity and computer training facilities are available. Purchase of books, magazines and other publications related to IT, e-Governance, modern digital extension techniques, social media applications in Agriculture etc for Cyber Extension Centers. Purchase of equipments, hardware and software for IT and e Governance training infrastructure, Agricultural Knowledge Management and repair and maintenance & AMC of

computer Lab items, Extra Connectivity/bandwidth pumping to network for training and special connections for Computer Labs from high speed connectivity providers, Connectivity Account Charges etc

4. Purchase of books, Subscribing Magazines ,CD's, DVDs ,Blue Ray discs

Training Materials etc related to IT and e-Governance Projects.

5. AMC for IT and Communication Infrastructure at Directorate and Computer Labs/other offices, Software licenses and AMC for virtual Class rooms, Purchase of Software for extension and Security in offices of Agriculture Department.

6. Networking of the present infrastructure at various offices for optimum

efficiency and synergy in IT and e-Governance operations.
