ATMA is one of the efficient approaches in delivering advanced technologies in the field of agriculture as far as the new initiatives in extension are concerned. It is rather an innovative approach than the existing set up with a view to achieve the targeted 4% growth in agricultural sector so as to move our nation into the "Developed Nations Group". The ATMA programmes are aimed at changing the traditional pattern of implementation of different agricultural plan components and approaching the system in a more professional way. ATMA encompasses the single window system of service delivery, irrespective of the farmers' enterprises such as agriculture, animal husbandry, fisheries, poultry, dairy etc.

ATMA is a Centrally Sponsored Extension Programme which focuses on farmer oriented activities, farm information dissemination and establishing farmer scientist linkage. For achieving these objectives additional manpower support is required. Under this background the programme of hiring of man power for the effective extension delivery is proposed.

Government has accorded administrative sanction for the scheme strengthening of Agricultural Extension. Under this scheme an amount of **Rs. 200 lakhs** is set apart for the component "**HR Support to Project Directorate and Extension wing**" under the head of account 2401-00-109-80 plan during the year 2018-19. Vide ref 2<sup>nd</sup> cited above continuous sanction has been accorded for the implementation of the aforesaid scheme.

### **Objectives:-**

- Man power support for Extension services
- > Empowering the extension personnel with modern devices for communication.
- Making use of the services of eminent consultancy agencies for monitoring extension services and obtaining vital inputs for efficient planning and management of extension programmes.

### Programme:-

The various components of the schemes under this programme are given below

## 1. Honorarium to District Technology Managers in Agriculture and allied sectors

25 District Technology Managers are engaged in 14 districts and in Head Quarters in Agriculture sector. 20 DTMs are appointed in allied sectors i.e., 14 DTMs (one each in 14 districts) in Animal Husbandry and 6 DTMs in Fisheries in Thiruvananthapuram, Kollam, Alappuzha, Kannur, Trissur and Kozhikode districts, The total amount for the honorarium is Rs.135 Lakhs @ 25000/- per month. They will co-ordinate technology management activities at block level. The Technology Managers will also perform data consolidation work and create a real time data bank of field level problems and enquires. They will be responsible to record the outcomes of meetings and seminars and various field problems for onward transmission to higher authorities. The District Technology Managers strengthen and support the extension activities at district level and DTM at State Level Nodal Office will coordinate the activities in the state level by collecting the required information from all the districts. All reports on ATMA and other extension activities will be collected by DTMs at districts and State Nodal Office.

## 2. Human Resource Support at FTC, Pandalam and Vengeri

Two Technical officers with BSc (Ag.) a qualification is appointed each at FTC Vengeri and Kozhikode on contractual basis with an honorarium of Rs. 25000/- per month. An amount of Rs.12 lakhs is set apart for this component.

# 3. Honorarium and travel expenses to faculties engaged in RATTCs and FTCs

An amount of Rs.14.00 lakhs is set apart for this component.

## 4. Providing course material for trainees at RATTCs and FTCs

An amount of Rs.32.50 lakhs is set apart for this component

# 5. An amount of Rs.6.50 lakhs is provided for miscellaneous expenses including Festival allowance and Earned leave surrender

The Monthly Progress Report regarding 3<sup>rd</sup> and 4<sup>th</sup> component should be collected by DD (E & T) from RATTC/FTC and should be handed over to PD, ATMA. The consolidated MPR of the scheme should be submitted to State Nodal Cell in the email ID (nodalatmakerala@gmail.com) on or before the 5<sup>th</sup> of every month by PD, ATMA.
