ORDER

The Government of India have launched a new Central Sector Scheme, namely "Pradhan Mantri Kisan Samman Nidhi (PM-KISAN)" with 100% financial assistance. Under this scheme, financial benefit of Rs.6,000/- per year will be provided to all small and marginal farmer families having total cultivable holding of upto 2 hectares. This will be provided in 3 equal instalments of Rs.2,000/- each in a period of four months in a financial year. The benefit shall be admissible for the transfer with effect from 1.12.2018 for this scheme. The Government of India have communicated the detailed Operational Guidelines for implementation of the scheme

including transfer of benefit to the eligible beneficiaries alongwith specific eligibility criteria and exclusion criteria.

- 2. As per the guidelines read as 1st paper above, a small and marginal landholder farmer family for the purpose of the calculation of the benefit is defined as "a family comprising of husband, wife and minor children (upto 18 years of age) who collectively own cultivable land upto 2 hectares as per land records of the concerned State/Union Territories. The existing land ownership system in the States will be used for identification of beneficiaries. Those whose names appear in land records as on 01.02.2019 shall be eligible for benefit. If a Landholder Farmer Family (LFF) has land parcels spread across different villages/revenue records, then land will be pooled for determining the benefit.
- 3.The Government of India have requested the State Governments to prepare database of beneficiary Small and Marginal landholder farmer families in the villages capturing the Name, Gender, whether belonging to SC/ST, Aadhaar Number (Aadhaar Enrollment Number in case Aadhaar Card has not been issued), Bank Account Number and Mobile Number of the beneficiaries. For transfer of first instalment of benefit for the period from 01.12.2018 to 31.03.2019, Aadhaar number shall be collected wherever available and for others, alternate prescribed documents namely driving license, voters' ID Card, MGNREGS Job Card or any other identification document issued by Central or State Government or their authorities etc. can be collected for identity verification purposes. However, for transfer of subsequent installments, Aadhaar number shall have to be compulsorily obtained. State Government shall ensure that there is no duplication in the names of the eligible families. Speedy reconciliation in case of wrong/incomplete bank details of the beneficiary should be ensured by the State Government.
- 4. Under this Scheme, the benefit will be transferred by Government of India to the bank account of the beneficiaries through State Notional Account. For transfer of benefit, District-wise list of beneficiaries shall be certified and uploaded by the State Government on the PM-KISAN Portal of Government of India and the funds will be electronically transferred to the beneficiary's bank account by Government of India through State Notional Account on a pattern similar to MGNREGS. The funds pertaining to income support benefit will be released from Government of India periodically based on receipt of fund transfer order through the concerned State Government with the eligible beneficiaries' details. The State Governments shall also notify District Level Grievance Redressal Committees for redressing all grievances related to implementation of the scheme and ensure adequate publicity of the scheme as the intended beneficiaries are located in rural/remote areas. The beneficiary lists should be displayed/verified at Gram Panchayats to ensure greater transparency and accuracy of the list.

- 5. The Government of India have also requested the State Governments to designate a Nodal Department for implementation of the Scheme. Maximum @ 0.25% of the funds transferred to beneficiaries in the first installment and thereafter maximum @ 0.125% for the subsequent installments shall be provided as administrative expenses to State Governments to cover the expenditure on their Project Management Units, if established and for meeting, other related administrative expenses including cost to be incurred for procurement of stationery, field verification, filling of prescribed formats, their certification and its uploading as well as incentive for field functionaries etc. States will furnish the details of the account to which administrative charges are to be credited by the Central Government.
- 6. Accordingly as per letter read as 2nd paper above Director of Agriculture reported that Additional Director of Agriculture (Extension) in the Directorate of Agriculture Development and Farmers' Welfare Department will be the State Nodal Officer of the Scheme and a Project Monitoring Unit (PMU) has to be formed comprising Additional Director of Agriculture (Extension)- Nodal Officer, Additional Director of Agriculture (Planning)- Member, Deputy Director of Agriculture (IT)-Member, Assistant Director of Agriculture (TS Section)- Member. The PMU at head quarters will monitor the scheme at State level. It is also reported that a Distric Level Grievance Redressal Committee for redressing all grievances may be constituted with the District Collector as Chairman, Principal Agricultural Officer as Convenor, Deputy Director of Agriculture (Credit) as member, Assistant Principal Agricultural Officer as member and the concerned Tahasildars or Village Officers as member. Director of Agriculture has requested sanction for the following.

a) Identify a bank and designate it as sponsoring bank of this scheme and Government may consider designating the same bank being used for the transferring of fund for MNREGS as sponsoring bank for this scheme.

- b)Administrative Sanction for the implementation of the Scheme PM-KISAN and to designate Agriculture Development and Farmers' Welfare Department as Nodal Department of the State for the implementation of the scheme
- 7. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the implementation of the scheme Pradhan Mantri Klsan SAmman Nidhi (PM-KISAN) in the state and Agriculture Development and Farmers Welfare Department is designated as state nodal Department for co-ordinating with Central Government with regard to the implementation of the scheme. Additional Director of Agriculture (Extension), Agriculture Development and Farmers Welfare Department is nominated as the state nodal officer of the scheme.

8. As per the Government Order read as 3rd paper above sanction is accorded to the Director of Agriculture for opening a State Notional Account in any nearest branch of State Bank of India so as to facilitate fund transfer from Central Govt. to

the identified beneficiaries under this scheme.

9. The Government constitutes a Project Monitoring Unit (PMU) for monitoring the scheme at directorate level with the following members and the same will act as state level redressal committee.

Sanction is also accorded to the Director of Agriculture for appointing one Data Entry Operator in each Krishi bhavan and in the O/o Block level Assistant Director of Agriculture in all district for uploading the data of beneficiaries with administrative expenses of Rs.5 per beneficiary. The expenditure in this regard can be met at a rate of 0.25% of amount earmarked for the first installment. It is also ordered that 10% data is to be cross verified at random at the block level.

11. The guidelines issued by Government of India as per letter read as 1st paper above shall be strictly followed.
