Administrative Sanction has been accorded as per the reference cited, for the implementation of scheme Farm Information and communication for the year 2017-18 with a provision of Rs. 400 lakhs under the H/A 2401-00-109-84 plan. The scheme aims at the development of information dissemination through the use of Mass media, and electronic media including web based services.

Farm Information Bureau (FIB) is the only agency under Department of Agriculture providing active and complete information support to accelerate the extension and developmental activities of the Department of Agriculture, Animal Husbandry and Dairy Development. The Bureau takes up the propaganda works of these departments to help the farming community in availing various benefits offered by the Government. It works as an effective link between research stations and farming community by disseminating right scientific knowledge to the right person at the right time and providing feeddback to the research community. Head Office of Farm Information Bureau is at Thiruvananthapuram with two Regional Offices at Ernakulam and Kozhikode. The scheme 'Farm Information and Communication' 2017-18 is sanctioned for carrying out its various activities during 2017-18. Various components of the scheme are described under three headings.

1 KERALA KARSHAKAN

During the year 2017-18 a total of Rs. 1,91,500,00/- (Rupees One Crore Ninety One Lakh and Fifty Thousand Only) is sanctioned for various activities related to Kerala Karshaka Magazine.

a Kerala Karshakan: Kerala Karshakan is the Malayalam Journal Published by Farm Information Bureau, right from 1954. It contains articles not only from the field of Agriculture but also from Animal Husbandry and Dairy. The Magazine has now a monthly circulation of 1.5 Lakhs. It has been changed with attractive layout, more field level farm reports, success stories, technical articles etc.

Charges of Kerala Karshakan,

Rs.3,50,000/- is provided for honorarium to authors of Kerala Karshakan, and mailing charge of Kerala Karshakan. Rs. 25,000 is provided for Stationery Expenses and Rs.1,20,000/- for transportation charges related to Printing and publishing of Kerala Karshakan.

- b. Kerala Karshakan E- Journal: Farm Information Bureau, also publishes Kerala Karshakan English as e- Journal by the editorial team of Kerala Karshakan Magazine in Farm Information Bureau website. Rs.1,00,000 is allotted for Designing Charge and Rs. 1,80,000/- as remuneration to authors of E-Journal.
- C. Awards to agents: Rs. 50,000/- is provided for giving awards to agents enrolling maximum number of subscribers.
- d. Farm Photography competition and Essay writing competition for schools students: Kerala Karshakan is the one and only Magazine conducting state level farm Photography contest, to the public and essay writing competition offering to the students at various level on farming and awarding attractive prize money and certificates. Rs.75,000/- is set apart for the Farm Photography competition being the prestigious programme conducted by Farm Information Bureau and one and only of the same kind. The prize money for the winners will be Rs. 25,000/-, 15,000/-, 10,000/- for the first, second and third places and Rs.2,500/- each for the ten persons as consolation prizes.

For the conduct of essay writing competition students Rs.50,000/- is allotted for awards to students and honorarium for judges of essay writing competition.

- e. Photography Exhibition and Kerala Karshakan Compaign: Rupees 100,000/-(one lakh) is provided for conduct of Photography Exhibition and conduct of campaigns for Kerala Karshakan.
- f. Awards to officials: Awards to officials in Agriculture, Animal Husbandry and Diary Development is given for maximum number of enrilment of Kerala Karshakan. Rs. 1,00,000/- is alotted for this component.

2 EXHIBITION

Exhibition are conducted within and out of the state to provide information regarding various Government schemes of Agriculture, Animal Husbandry, Dairy Development Department, Progressive farmers, youth and students.

Farm Information Bureau is participating in major exhibitions like India International trade Fair (IITF) in New Delhi, Flora Expo in outside the state, Thrissur Pooram Exhibition,

State level Agricultural Fairs, State Vegetable Development Programmes, Global Agro Meets, Karshaka Dinam, Organic Kerala Campaigns etc. More over small scale rural exhibitions are also organized through out the state.

For projecting the latest theme in agricultural sector, Farm Information Bureau will present a float in the pageantry in connection with Onam Tourism Week Celebration of the State every year.

a Major Exibitions

This include major exhibitions like International Trade Fair (IITF) at New Delhi, Flora Expo, Thrissur Pooram, other exhibitions in connection with Karshaka Dinam, Niravu, Puthari, Karshakasri Fest and other exhibitions in agriculture and allied sectors. An amount of Rs. 13 lakhs is set a part for this section during 2017-18. This include the cost for the construction of pavilions, cost of exhibits and printing charges for brochures and documents, rent, electricity and water charges, fuel consumption etc. Farm Information Bureau is now participating more in major exhibitions than before. In these circumstances an amount of Rs. 13 lakhs is set apart for participating major exhibitions.

b Rural Exhibitions

As agriculture is rural activity, rural exhibitions, providing an excellect tool for agricultural extension. The exhibitions wing of Farm Information Bureau now participates in large number of rural exhibitions within the state with the co-operation of regional offices. It includes various rural exhibitions of Government department programmes, Press Information Bureau, Social Service Societies, Karshaka Vikasana Samithies, non government organisations and various local rural programmes like Palode, Vithura, Malayankeezhu, Arivikkara, Varkala Sivagiri and exhibitions in schools and major temples. The regional offices and so participate on many rural exhibitions conducted within their area of operations. On this occations, in addition to the amount set a part for rural exhibitions ammount of Rs. '4 lakhs is sanctioned (total Rs. Four Lakhs) for the well participation in rural exhibitions.

3 Kerala Karshakan Readers Forum

Farm Information Bureau conducted Kerala Karshakan Readers Forum. Kerala Karshakan Subscribers. Meet Or Readers. Forum meetings are conducted independently or along with Kissan Melas to increase the circulation of the magazines and for getting feedbacks, make farmers online subscriptions, interraction with farmers at district level etc. It is organized and conducted by campaign wing. 10 number of Readers Forum meetings proposed to be conducted for 2017-18. (4 number for Headquarters and 3 each for

Ernakulam and Kozhikkode regional offices). An amount of Rs. 1 lakhs is provided for the conduct of Kerala Karshakan Readers Forums.

Eminent journalists, expects from print and electronic media, Scientists from Agricultural University etc. Will be invited as Resource Persons in the workshop-Rs.5 lakhs(Rupees Five Lakhs Only) is provided for the conduct of the Farm Feature workshop.

6 CYBER EXTENSION

The Farm Information Bureau is having internet connection to access and transfer the same to farming community through cyber extension development at National and International level of Agricultural Sector Rs. 2.75 lakhs. Is sanctioned for upgradation of software and hardware as part of cyber extension.

From the current financial year (2017-18) onwards, the wages of Junior Programmer who is in charge of website has to be paid from Plan Head. The amount required for meeting this expense will be 2.25 lakhs.

For providing infrastructure facilities of media room in the newly constructed building Farm Information Bureau compound at Thiruvananthapuram, an amount of Rs. 10 lakhs has been allotted previous year as 1st phase for puchase of editing software monitor, audio equipments, video recorder, LED monitor, with necessary equipments and furniture for the studio. For the second phase development of media room additional an amounft of Rs. 10 lakhs is sanctioned.

9 FUEL CHARGE AND TRAVELLING EXPENSES

The activity of the Farm Information Bureau requires lot of mobility. There are 2 vechicles in the headquarters and one each at two regional offices at Ernakulam and Kozhikkode. An amount of Two lakhs is sanctioned for meeting the fuel expense and Rs. 1 lakh for repair and maintenance. More over 4 lakhs is sanctioned for travelling expense of the staff of Farm Information Bureau Headquarters and two regional offices.

2 ADVERTISEMENT
