Since this is an e-tender, only those bidders who have enrolled in the above portal with their own digital signature certificate (DSC) can participate in the tender. E-Tender document and other details can be obtained from the above e-portal.

Period of Supply : Within 15 days of receipt of supply order.

The bidder desiring to take part in the bid shall log into https://etenders.kerala.gov.in/ and then select tender and initiate payment. Bidders will be directed to the payment gateway page of the State Bank of India. There are two options – (1) State bank of India (SBI Net banking payment) and (2) Payment through NEFT from other banks to the payment gateway of SBI.

For obtaining digital signature certificate (DSC) and necessary portal enrolment bidders can visit the website https://etenders.kerala.gov.in/

The e-tenders submitted by the competent Manufactures/dealer/supplier should contain a scanned and signed copy of the product offered declaration sheet of the tractor and accessories which are most suitable for getting maximum output for the equipment intended for supply. Any under capacity accessories quoted with an intention to reduce the cost may lead to the rejection of technical bid of the firm.

Tenders will be opened in the online presence of such bidders or their

authorized representatives who have logged in at the prescribed time of opening. If the date fixed for opening happens to be a holiday or due to net failure the tenders will be opened in the next working day, at the same time.

The price of the e-tender tender form shall be received only through online payment -SBI / NEFT from other banks.

Scanned copy of the agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/- should be submitted online** and original to the undersigned before the opening of the e-tender.

The rates should be quoted in Indian currency only.

Details with respect to the e-tender and the details of specifications of the item to be purchased can be obtained from the e-tender website https://etenders.kerala.gov.in

The committee headed by the Assistant Executive Engineer (Agri) Kottayam will scrutinize the tenders received and will take necessary action for the award of tender. The decision of the Assistant Executive Engineer (Agri) Kottayam will be final for the award of the contract.

The rules and regulations prescribed for e-tenders by the Government of Kerala shall be applicable to this e- tender also.

Special Conditions:

- 1. The manufacturers or their authorised dealers are eligible to participate in the tender and necessary documents are to be produced along with tender.
- 2. The rates should be quoted should be inclusive of all taxes, cesses etc.
- 3. The rate should be inclusive of transportation, handling or any other cost of installation/ supply and the firm must **supply the items at the location specified in Annexures** or as per the direction from the undersigned.
- 4. The supplier should confirm the repair & service facilities, availability of spare parts etc., of the machineries and equipment's supplied by them.
- 5. Acceptance of tender for the supply of equipment on the invitation will be subject to tenderers certifying that they have adequate servicing and spare parts facilities in respect of the equipment tendered for by them or that they shall arrange to provide such facilities simultaneously with the supply of the equipment.
- 6. Tenderers shall also undertake that supplies of necessary maintenance

- equipment and spare parts will be made available for useful life of the machine on a continuous basis.
- 7. The successful tenderer shall warranty that before going out of production of the spare parts he will give adequate advance notice to the department so that the later may order his requirements of spares in one lot, if department so desires.
- 8. The successful tenderer shall further guarantee that if he goes out of production of spare parts, then he will make available blueprints, drawings of the spare parts and specifications of materials at no cost to the purchaser as and when required in connection with equipment to enable the purchaser to fabricate or procure spare parts from other sources.
- 9. The tenderer will undertake to offer accessories for delivery along with the tractor only and not before/after
- 10. Tender evaluation will involve recording and analyzing the merits of each tender. The process will start with preparation of "Comparative Statement" based on product offered statement and other documents furnished by bidders incorporating the commercial terms offered. Comprehensive analysis of the techno-commercial offer will form the basis for subsequent decision.
- 11. The catalogue/ leaflets/Pamphlets/Test certificate ... etc of the product offered should be submitted along with the tender
- 12. There will be no negotiation if price quoted is considered reasonable else negotiation will be held only with the lowest bidder i.e. L1.
- 13. A minimum warranty period of 2 years is to be assured for the items supplied.
- 14. Authorized test report from competent authority should be attached wherever applicable.
- 15. The Assistant Executive Engineer (Agri) Kottayam reserves the right to award the full quantity of supply to any one supplier or distribute the supply to different suppliers or to change the quantity of supply without assigning reasons thereof.
- 16. A scanned copy of preliminary agreement signed in Kerala stamp paper

worth Rs. 200/- should be uploaded along with tender documents.

- 17. EMD, Cost of Tender form+18%GSTetc.Should be made as a single payment through online.
- 18. The successful tenderer will have to execute an agreement in stamp paper worth Rs. 200/- in prescribed form and manner and to furnish the required security amount @ 5% of total quoted amount within 14 days of the receipt supply order.
- 19. The payment shall be released only after satisfying the qualities and specifications of the item supplied.
- 20. Tender received incomplete in any respect will be summarily rejected and the decision of the undersigned on such matters will be final.
- 21. The supply should be completed within thirty days on receipt of the supply order.
- 22. If found necessary, field demonstrations of the machinery shall be done at the cost of the tenderer before the technical/ expert committee constituted for the purpose to finalize the selection and the decision of the technical committee will be the final and binding.
- 23. The supplier should undertake field demonstration and operators training in the respective districts, if found necessary.
- 24. The manufacturer/supplier must produce the following documents in this office both physically and online before the opening of the tender otherwise tender will be strictly rejected without any notice and the EMD will be forfeited to govt. Documents in physical form should be submitted only through registered post/speed post
- 25. The bidder should have supplied a minimum of ten numbers of the quoted equipment or same brand during the last three years and the list of beneficiaries should be attached in the prescribed Performa in Annexure II
