As per the Government order under reference, administrative sanction has been accorded for implementation of scheme component *Project based support for establishment of nurseries through FPOS* (Farmer producer organizations) under the scheme "Development of Spices" 2020-2021 for an amount of Rs 26.04 lakhs (Rs Twentysix lakhs and four thousand only) under H/a 2401-00-108-59(p) for 4 project proposals from wayanad and Kannur.

The objective of the scheme are as follows

- 1.To provide project based assistance for the development of spices
- 2. To produce good quality planting materials and manures ect
- 3. To produce safe to ear produce and improve exporting possibilities
- 4. To train farmergroup in nursery management etc

Three projects from Wayanad and one project from Kannur were received ,which were placed in the $3^{\rm rd}$ working group meeting on 29/06/2020 and administrative sanction was accorded for an amount of Rs 26.04 lakhs(Rs Twentysix lakhs and four thousand only).

The following general Conditions should be followed, wherever applicable.

- 1. All rules, formalities and procedures shall be strictly followed for the implementation of the schemes. The norms of financial propriety shall be adhered to.
- 2. The expenditure would be met from the provision available under the appropriate head of account.
- 3. The fund release will be based on actual requirement, and the fund released should not be parked in banks.
- 4. Store purchase Rules shall be strictly adhered to for all kinds of purchases.
- 5. Tender/e-tender and other stipulated formalities shall be followed wherever necessary
- 6. Post creation and purchase of vehicles are not admissible under the schemes.

Mode of implementation

The scheme will be implemented through the Krishibhavans of the selected districts. At block level, Assistant Director of Agriculture will co-ordinate and supervise the programme. At the district level, the Deputy Director of Agriculture (H) will be the nodal officer and at the state level, Additional Director of Agriculture (CP) will monitor the programme.

All the assistance to the farmers should be credited to the bank account of the concerned beneficiaries through e -payment.

Principal Agricultural Officers are hereby directed to keep utmost vigil in implementing the scheme and achieve the targets in full. The monthly progress report in the prescribed proforma should reach this office on or before 5th of every succeeding month in the name cover of Additional Director of Agriculture(CP). An MOU has to be signed by the Principal Agricultural Officers on behalf of Director of Agriculture with the implementing agencies before release of funds. It should also been sured that the Utilization Certificate pertaining to the scheme are submitted by these agencies in time.
