On behalf of the Governor of Kerala, e-tenders are invited from reputed, experienced individuals and firms for **Providing Light & sound system for the Exhibition and International Workshop on Agro Processing and Value Addition, VAIGA AGRI HACK 2021**, being held at Thrissur from 10.02.2021 to 14.02.2021. The tenders are to be submitted as e-tenders through <https://etenders.kerala.gov.in>. Since this is an e-tender, only those bidders who have enrolled in the above portal with their own digital signature certificate (DSC) can participate in the tender. E-Tender document and other details can be obtained from the above e-portal.

Cost of e-Tender & E.M.D. (online Payment) : ₹ 2500 /- for cost of Tender form and Rs. 19,600/- for EMD shall be made as single payment through online.

GST and Kerala Flood Cess on cost of tender form, Rs. 450/- and Rs. 25/- respectively shall be paid directly to GST department and proof of remittance should be uploaded along with the tender documents.

Date up to which the rates are to remain firm for acceptance: 30 Days from the date of opening

Performance Security: 3% of total contract amount.

The bidder desiring to take part in the bid shall log into <https://etenders.kerala.gov.in>. For obtaining **digital signature certificate** (DSC) and necessary portal enrolment bidders can visit the website <https://etenders.kerala.gov.in/>

The hard copies of tender documents, shall be submitted subsequently after online submission of bids before the date and time of opening of the bid.

If the date fixed for opening happens to be a holiday the tenders will be opened in the next working day, at the same time.

Scanned copy of the agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/- should be submitted online** and original to the undersigned before the opening of the e-tender. The rates should be quoted in Indian Rupees only.

The rules and regulations prescribed for e-tenders by the Government of Kerala shall be applicable to this e-tender also.

Special Conditions:

1. The individuals or firms should execute, comply the conditions of the contract, in accordance with the contract, to the complete satisfaction of the Department/ Authorized dignitaries.
2. It is duty and responsibility of the contractor to obtain mandatory permission from the authorities like Police, Fire Force, Local body, Electrical Inspectorate etc for the smooth and successful conduct of the programme.
3. **The rates quoted for the service should be inclusive of all charges like, labour, transportation and other overheads, but excluding GST.**
4. In case of default on the part of the bidder in carrying out any order, Department shall be entitled to get the work done by any other persons / agencies and all expenses consequent thereon or incidental thereto shall be deducted from the bidder.
5. The decision of the Department in the matter arising out of this contract shall be final and binding in regard to all matters relating to the contract.
6. The Department shall have right to issue addendum to tendered documents to clarify, amend, modify, supplement or delete any of the condition, clause of items stated therein. Each addendum shall form a part of the original invitation to tender.
7. The work is inclusive of transportation, handling or any other cost of installation/ supply and the firm has to supply and erect the items at the location specified by the under signed or by the authorized person.
8. The Department reserves the right to award the full quantity of work to any one bidder or to distribute the work to different bidder without assigning reasons thereof.
9. EMD Rs 19,600/-and Cost of Tender form Rs. 2,500/-should be made as a single payment through online.
10. The successful tenderer will have to execute an agreement in stamp paper worth 0.1% of quoted amount in prescribed form and manner and also to furnish the required security amount @ 3% of total quoted amount within 2 days of the receipt of selection notice and should start the work immediately.
11. The payment shall be released only after satisfying the qualities, quantity, specifications of the work executed, service provided, items supplied and its successful completion.
12. The Department has the full right to delete or add any item/quantity in the schedule of quantities.
13. Tenders received incomplete in any respect will be summarily rejected and the decision of the under signed on such matters will be final.
14. **The works should be completed on or before 09.02.2021, 4.00 PM and handed over to the organiser to their fullest satisfaction.**
15. Income Tax, GST, KCWWFB contribution etc.. will be deducted from the bill at the rates applicable at the time of making payment.
16. All conditions of Kerala Government and rules related to similar tenders are applicable in this case also.
17. Green protocol shall be followed in all article, fabrication and decoration works
