Continuous Administrative Sanction was accorded vide reference 1<sup>st</sup> cited above for the implementation of the scheme 'Development and Promotion of Location Specific Crops' during 2020-21 for an amount of Rs.158.3027 lakh under head of account 2401-00-103-75 (P) with the following components:

Vide reference 2<sup>nd</sup> cited above, the implementing section for the scheme at HQ has informed that various districts have requested for surrender of funds allotted under the scheme for the component "Promotion of annual oil seeds", and the Principal Agricultural Officer, Idukki has requested for additional funds under the component "Promotion of Sugarcane". As is the case, the implementing section has requested that the savings available under the component "Promotion of annual oil seeds" may be utilized to meet additional

requirement under the component "Promotion of Sugarcane". The details of revision in components are as follows:

# Promotion of annual oil seeds (Sesamum & Groundnut)

It is proposed to provide financial assistance @Rs.5000/ha for cultivation of sesamum in potential pockets of the State like Onattukara region in Alappuzha district and in other traditional tracts like Malappuram district.

It is also proposed to provide financial assistance @ Rs.15,000/ ha for cultivation of ground nut in traditionally cultivated areas and non traditional areas in Alappuzha, Palakkad and other districts.

Assistance proposed is towards the cost of seeds, manures and fertilizers, Plant protection chemicals and cost of land preparation. It is proposed to provide assistance for cultivation of oilseeds in 1127.54 ha with a financial commitment of Rs.77.001 lakhs. The details are as furnished below.

## 3) Promotion of Sugarcane

At present, the sugarcane crop is predominantly concentrated in central Travancore region, Marayur region in Idukki district and in tracts of Palakkad district.

Assistance will be provided for quality planting materials, land preparation, irrigation, plant protection, harvesting, transportation, setting up of processing units etc. It is proposed to provide assistance @ Rs.20,000/ha, for taking up sugarcane cultivation in an area of 366.5085 ha. An amount of Rs.73.3017 lakhs is earmarked for this component.
