Insecticide Licence - Guidelines

Insecticide Act 1968

- To regulate the import, manufacture, sale, transport, distribution and use of insecticides to prevent risk to human beings or animals.
- ➤ Insecticides Rules 1971- contain provisions for the application / enforcement of Insecticide Acts.
- Insecticides (Amendments) Rules- To change the provisions for the application / enforcement of Insecticide Acts.

Major Amendments

> Insecticide (Amendment) Rules 2015-

As per GSR 840(E) dt.05/11/2015

- 1. The word 'renewal' deleted for the Manufacturing and Distribution licenses.
- 2. Sub rule 4B inserted under Rule 9 A person who applies for manufacturing license shall employ a person possessing Master's degree in chemistry with a Doctorate or a graduate degree in Chemical Engineering for manufacture of technical grade pesticides or a Graduate degree in Agricultural science with Chemistry for manufacture of pesticide formulations within a period of 2 years from the date of publication of this Amendment.
- 3. Sub Rule 1A inserted under Rule 10 A person who applies for grant of license to sell, stock or exhibit for sale or distribute insecticides shall possess or shall employ a person possessing a graduate degree in Agricultural science or Biochemistry or Biotechnology or life science or in science with Chemistry or Botany or Zoology or in Science, within 2 years from the date of publication of this Amendment.

> Insecticide (Second Amendment) Rules 2017-

As per GSR 106 (E) dt.01/02/2017 - Rule 10 (1A) substituted) - as

A person who applies for grant of license to sell, stock or exhibit for sale or distribute insecticides shall possess or shall employ a person possessing a graduate degree in Agricultural science or Biochemistry or Biotechnology or life science or in science with Chemistry or Botany or Zoology as main.

One year Diploma course in Agriculture or Horticulture or related subjects from any Govt. recognized University or Institute with course content on plant protection, within 2 years.

Existing pesticide licence holders who are more than 45 years of age and who have been running their trade eithr themselves or have inherited with cumulative period of experience of more than 10 years as on the date of publication of these rules and the annual turnover is less than Rs. 5 lakhs are exempted from the aforesaid Rule for a period of license ship continuing in their name.

> Insecticide (3rd Amendment) Rules 2017-

As per GSR 1229 (E) dt.04/10/2017 - Rule 9 (4B) substituted- as

A person who applies for manufacturing license shall possess or shall employ a person possessing the following educational qualification:-

(i) Doctorate in Chemistry or Agrl. Chemistry or Agrl. Chemicals Or Master of Technology or Master of Science in Chemical engineering or equivalent for manufacture of technical grade pesticides.

Or

(ii) Master degree in Science with Chemistry or Agricultural Chemistry or Agrl.

Chemicals or equivalent for manufacture of pesticide formulations and the time allowed to comply with the educational qualification extends to two years wef. 04/10/2017

> Insecticide (Amendment) Rules 2019

As per GSR GSR 11 (E) dt.03/01/2019 - period to amend existing license holders to acquire qualification / employ qualified persons extends to three years wef. 6/2/2017

➤ Insecticide (Amendment) Rules 2018-

As per GSR 399 (E) dt.20/04/2018 - the forms for application of licence, grant of licence, principal certificate, register of date expired pesticides, register of sale/distribution of insecticides etc. have amended.

Application for Insecticide License

- > Only for fresh license, application in Form II is required.
- According to the type of License required, documents as per the checklist have to be submitted.
- For any addition/deletion/ changes in the existing license, application in white paper along with original license and related documents has to be submitted for amendments.

> Application should be thoroughly scriming to the Directorate

Guidelines to Scrutinize license Application

Validity of License

- > Validity of Manufacture license is based on the validity of Certificate of Registration.
- > Validity of wholesale/retail license is based on the validity the Principal Certificate.
- > Validity of PCO license is for 5 years and it has to be renewed after 5 years
- ➤ Renewal application for PCO should be submitted in Form II along with Chelan for Rs.1000.

Amendment of License

- Any change in the Name, address, Technical person, building No. etc. occurred, it has to be amended in the existing license by putting an application in white paper along with the original license and required documents. No fee is required.
- > If a licensee wants to manufacture, sell, stock or exhibit for sale or distribute any additional insecticides during the currency of the license, he may apply to the licensing authority for necessary endorsement on the license on payment of prescribed fee.

CONDITIONS

- 1. This licence shall be displayed in the prominent place in the premises for which the license is being issued and shall be produced for inspection as and when required by an Insecticide Inspector, licensing officer or any other officer authorised by the Government in this regard.
- 2. Any change in the name of the expert staff, named in the license, shall forthwith be reported to the licensing officer.
- 3. The licensee shall scrupulously comply with each and every condition of registration of the insecticide(s), failing which the licence is liable to be cancelled.
- 4. No insecticide shall be sold or exhibited for sale or distributed or issued for use in commercial pest control operations except in packages approved by the Registration Committe from time to time.
- 5. If the licensee wants to manufacture / sell, stock or exhibit for sale or distribute / stock and use for commercial pest control operations, any additional insecticide, he may apply to the licensing officer for addition in the licence for each such insecticide on payment of the prescribed fee.
- 6. For pest control operations an application for the renewal of the licenssee shall be made as laid down in sub-rule(3A) of rule 10 of the insecticides Rules, 1971.
- 7. The licensee shall comply with the provisions of the Insecticides Act, 1968 and the rules made there under for the time being in force.
- 8. The licence also authorizes the storage and stocking of insecticide(s) manufactured at the licensed premises, in the factory premises for sale by way of wholesale dealing by the licensee.
