Government have approved the select list, as per the Government

As on now, only 6 vaccancies of the Agricultural Officers under 13%
quota are available.

The incumbents on by-transfer are placed on probation for a period of 2 years of duty within a continuous period of 3 years from the date of officiation in the post of Agricultural Officer. They should also pass Account Test (Lower) within the period of probation.

The Principal Agricultural Officers should report the date of relief and joining of the incumbent along with the copy of the RTC to be reached to the undersigned and the Accountant General (A&E), Thiruvananthapuram in due course.

The Service Book of the incumbents should be forwarded to the Directorate of Agriculture, after updating all the entries by the Head of the office.


Since the sanctioned strength of Agricultural Officers under 13% quota is fixed as 143 under 13% quota and the posting of the junior-most Agricultural Officer should be liable to be reverted as and when the Agricultural Officer, on deputation will be reverted to the Department.
