1) The Candidate listed out in the annexure selected through  
Employment Directorate, Thiruvananthapuram vide reference 1<sup>st</sup> above is  
hereby appointed as Agricultural Officer in the scale of pay Rs.55200-  
115300/- purely on a temporary basis under rule 9 (a)(1) of KS & SS Rule  
1958 for a period of 179 days or till regular hands join duty, whichever is  
earlier. They are posted to the Krishi Bhavan noted against their name. The  
candidate should report for duty before the Principal Agricultural Officer  
concerned within 7 days on the receipt of their order. Otherwise the  
appointment order stand cancelled.

2) The Principal Agricultural Officer should verify the Qualification,  
Date of Birth, Disability Certificate, Community Certificate, etc of the  
candidate before admitting him/her for duty. It is also directed to confirm  
whether the B.Sc (Agri/Horti) Degree Certificate produced by the candidate  
is awarded from an approved University. In case of any doubt the copy of the  
Certificate may be sent to this Office for clarification.

3) It is proved later that the candidate has furnished false information to the Employment Exchange and if the candidate is nominated mistakenly by the Employment Exchange, they will be terminated from Service after giving an opportunity to explain their part.

4) An Indemnity Bond shall be got executed by the candidate before join duty as provided in G.O. (Rt) No. 1244/1994/Ad. Dated 09.09.1994. The Principal Agricultural Officer should report the date of joining duty/non joining duty of the Candidate to this office at the earliest.

5) The Principal Agricultural Officer should also observe the formalities as mentioned in the Government Order read as 5<sup>th</sup> above before admitting the Candidates for duty (copy enclosed).

6) The RTC of the candidate should be forwarded to this office as well as to the Accountant General (A & E), Thiruvananthapuram.
