Fruits comes under the category of protective food that supplies vitamins and minerals needed for our body and hence to be included in our daily diet. Our state has ideal climatic conditions for cultivation of a number of tropical and sub topical fruits.

Ethnic fruit varieties of mango, jack, guava, pomegranate, citrus etc have been used from early days. High value crops like avocado, litchi, dragon fruit, mangostein, passion fruit, rambuttan, durian ,phalsa etc can also be cultivated in areas of favourable climatic zones.

Vide reference cited, Administrative Sanction was accorded for the component "Subkishakeralam – Development of Fruits" under the scheme "Development of Fruits, Flowers and Medicinal Plants" 2021-22 for an amount of ₹ 100 lakh under the head of account 2401-00-119-79 (P).

Objectives

- 1. To increase the area under fruit varieties like Avocado, Litchi, Mangostein, Passion fruit, Rambuttan, Durian, Phalsa etc.
- 2. To increase the production and productivity of exotic fruits in the State.
- 3. To provide pesticide free fruits to the society.
- 4. To promote the cultivation of exotic fruit varieties.

Criteria for the implementation of the scheme

- 1. Area expansion of fruit crops like avocado, litchi, mangostein, passion fruit, rambuttan, durian, phalsa, etc.
- 2. Assistance is given as per the existing norms of State Horticulture Mission/Agriculture Department.
- 3. Assistance is given for meeting the expenditure on the cost of planting materials, cost of cultivation, cost of INM/IPM etc.
- 4. Preference to be given to FPO's.

- 5. Maximum area for which assistance can be given is upto 4 ha as per MIDH norms.
- 6. Rate of assistance-Exotic fruit crops for less cost intensive crops.
