Based on the documents submitted by you for the grant of fertilizer wholesale distribution license, Certificate No - KLAGRI- PFR- 211/2021 dt 17/12/2021 - valid upto 16/12/2026 was issued to your firm from this office. Further on arising suspicion on the genuinity of the documents submitted, verification was done with Government of Karnataka and it was informed by the Authorities of Karnataka that the documents produced by you are fake and fabricated. Hence the Letter of Authorization No - KLAGRI- PFR- 211/2021 dt 17/12/2021 - valid upto 16/12/2026 issued through KSWIFT to M/s WHOLE SALE LICENSE ORGANIC MANUARE , Building No 22/39B, Alattil.P.O, Mananthavady, Wayanad under the propreitorship of Sri. Usman Kalarithody, was suspended for a period of 15 days with effect from 29/12/2021.

However in order to provide an opportunity of being heard, you were directed to appear in person for a hearing in the chamber of Additional Director of Agriculture (CP) & State Licensing Authority on 31/12/2021 at 3.00 PM. Your authorized representative Sri. Abdul Latheef attended the hearing on your behalf and couldn't defend the finding that the documents produced were fake and was unable to disclose the facts for which hearing was conducted. The following violations of Fertilizer Control Order, 1985 are noticed.

- Clause 7 - Manufacture and sale of organic manures were carried out by the firm in Malappuram and Wayanad without getting License from Department of Agriculture.
- Clause 31 (a) - The Letter of Authorization has been obtained by wilful suppression of material facts or by misrepresentation of relevant documents.

Under the circumstances mentioned above the Letter of Authorization No KLAGRI- PFR- 211/2021 dt 17/12/2021 - valid upto 16/12/2026 issued through KSWIFT to M/s WHOLE SALE LICENSE ORGANIC MANUARE , Building No 22/39B, Alattil.P.O, Mananthavady, Wayanad under the propretorship of Sri. Usman Kalarithody stands cancelled with effect from 01/01/2022 and is debarred from carrying on the business of fertilizers.
