As per reference 1st cited Working Instructions were issued the component “HR Support to Project Directorate and Extension Wing” under the scheme “Strengthening of Agricultural Extension” under H/A 2401-00-109-80(P), where in an amount of Rs. 135 lakh was set apart for meeting the honorarium to DTMs (District Technology Managers) in Agriculture and Allied sectors @ Rs. 25000/- per month.

As per G.O. cited 2nd above,DTMs have been sanctioned honorarium on par with that of category VIII as per reference 3rd cited, the maximum monthly contract pay of category VIII contract staff has been revised to Rs. 30995/- per month.

Accordingly, the honorarium of DTMs (District Technology Managers) in Agriculture and Allied sectors is revised to Rs. 30995/- per month and the district wise financial target is revised as follows:


