(2) Payment through NEFT from other banks to the payment gateway of SBI.

For obtaining **digital signature certificate** (DSC) and necessary portal enrolment bidders can visit the website <https://etenders.kerala.gov.in/>

Tenders will be opened in the online. The bidders or their authorized representatives can log in at the prescribed time of opening bids. If the date fixed for opening happens to be a holiday/ due to net failure the tenders will be opened in the next working day, at the same time.

The price of the e-tender tender form shall be received only through online payment -SBI/ NEFT from other banks.

Scanned copy of the agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/-** should be submitted online and original to the undersigned before the opening of the e-tender.

The cost should be quoted in Indian currency only.

The Purchase committee headed by The Additional Director of Agriculture (Planning) will scrutinize the tenders received and will recommend suitably. The decision of the Director of Agriculture Development & Farmers Welfare Department will be final for the award of the contract.


