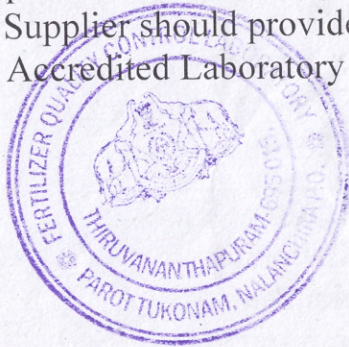


Special Conditions
