CIRCULAR

Sub:- Department of Agriculture Development and Farmers' Welfare - Annual Plan 2022-23 - Scheme"Development of Fruits, Flowers and Medicinal Plants"- component Development of Fruits - Subcomponent-Development of Infrastructure in Departmental Farms-H/A 2401-00-119-79 plan - Working instructions issued - regarding.

Government of Kerala vide Order reference cited as (1) above, have accorded administrative sanction for the scheme "Development of Fruits, Flowers and Medicinal Plants" for an amount of Rs. 1892 lakh (Rupees One thousand eight hundred and ninety two lakhs) under the head of account 2401-00-119-79-Plan. Out of this Rs.350 lakh is earmarked for the sub component - Development of infrastructure in Departmental Farms.

A massive programme "One crore fruit plants" phased for a period of 10 years for the development of fruit sector in the state was launched in the year 2020-21. "Distribution Of One Crore Fruit Planting Materials", is one of the major components of the scheme 'Development of Fruits, Flowers & Medicinal Plants'. The main objective of fruit development scheme is to expand the area under fruit cultivation in the state including indigenous and exotic fruit varieties. The planting materials of the scheme 'Distribution of One Crore Fruit Plants'

will be issued as grafts, layers, seedlings, suckers and tissue culture plants in a campaign mode as part of the ongoing 'Njangalum Krishiyilekku' programme of the Department of Agriculture. The major varieties included are Mango, Jack, Pomegranate, Guava, Sapota, Rambutan, Avacado, Mangostein, Jamun, Bread Fruit, Nelli (gooseberry), Garcinia, Jamba Varieties, Lemon Varieties, West Indian Cherry, Litchi, Lovilovi, Pulasan, Durian, Dragon Fruit, Passion Fruit, Anona/Custard Apple/Mullatha, Bilumbi, Papaya, Muringa, Curry Leaf, Miracle Fruit, Carombola, Baraba, Egg Fruit, Peanut Butter Plant, Banana Varieties, TC banana, Wood Apple etc. Grafts, layers, TC bananas will be distributed at 75% subsidy (25% beneficiary contribution) and seedlings, suckers will be issued free of cost. Departmental farms are the major producers of quality planting materials of fruits plants under Government Sector.

The production capacity of farms has to be increased to the maximum to reduce the dependence of other agencies for planting materials. This require development of infrastructure facilities including high-tech production methods.

The proposed activities for the Development of infrastructure in Departmental Farms are,

a. Construction and maintenance of polyhouses, rainshelter, hardening units etc and providing irrigation facilities in Departmental farms – Rs.100.00 lakh

Plant growing structures like mist chamber, polyhouse, shade net facility, rain shelter etc. are required for the production of quality planting materials of major fruit crops. These structures ensure better root growth, bud graft union, hardening and high success rate in plant multiplication. Irrigation resource is an important prerequisite necessary for the production of planting materials. An amount of Rs.100.00 lakh is earmarked for the construction and urgent repair of plant propagation structures, and for creating and improving the irrigation facilities of farms.

Detailed estimate for individual works of selected farms should be prepared and technical sanction obtained for them. The list of items/works selected should be forwarded to this office. The DDA(YP) should co-ordinate the works in the districts, the farm officers should prepare the proposals as per the requirement of implementation of the scheme components. The technical committee constituted at district level with Assistant executive Engineer(Agri) as member should facilitate the implementation of the components.

b. Production cost of seedlings - Rs.200.00 lakh

An amount of Rs.200.00 lakh has been set apart for meeting the production cost of quality planting materials of fruit plants which are suitable for the agro ecological units of Kerala. Improved methods of propagation like bud grafting, epicotyl/Stone grafting, approach grafting, layering etc are to be carried out by proving adequate training to the farm labourers or outsourcing these activities for the production of quality planting materials. The amount earmarked shall be utilised for meeting the input cost, management cost and all other expenses in

connection with the production of planting materials in Departmental farms. The district wise production target of planting materials for distribution under 'One crore fruit plant distribution programme is given as annexure-I

Action shall be taken at the farm level to produce maximum number of improved planting materials viz layers, grafts, bud grafts etc. The existing progeny or chards and mother gardens should be fully utilised to assure the supply of buds/scion requirement/layering purpose for the production of maximum number of quality planting materials of fruit plants to the farmers. The tissue culture lab facilities at DAF Anchal and DAF Thaliparamba should be fully utilised for the production of TC banana. The Departmental farms shall also collect Tissue culture banana plantlets from BMFC kazhakkuttam and hardened for distribution

c. Expansion of Progeny Orchards of exotic fruit plants @ Rs.5 lakh/ha-Rs.20.00 lakh

In order to assure the supply of maximum number of quality planting materials of exotic fruits plants in the coming years, the area under progeny orchards or mother gardens need to be increased. An amount of Rs. 20 lakh is earmarked for establishing progeny orchards of exotic fruit plants in 4 ha area of Departmental farms. The allotted funds shall be utilised for land clearing, land development activities, modern irrigation facilities, manuring, plant protection, purchase of planting materials, inputs etc. in connection with the area expansion of progeny orchards in departmental farms. Purchase of planting materials is to be done from approved sources. Microirrigation system should be adopted. This should be ensured by Principal Agricultural Officers with the help of Engineering Division of the Department. The full cost proposed for the establishment of progeny orchards in one hactre is Rs. 5 lakhs.

d. Ultra High Density Plantation (UHDP) of mango in Departmental farms- Rs.30.00 lakh

Ultra High Density Plantation (UHDP) is a new and proven technology commonly practiced for mango cultivation worldwide. Combined with other sustainable agricultural techniques, it has the potential to yield 200% more than by the traditional method. The UHDP mango plantation is a technique which has utilized all the resources optionally and thus increasing the production per unit area. UHDP ensures export quality of mango fruits by maintaining uniformity in colour, shape, flavour and freshness. The meadow orchard is a modern method of fruit cultivation using small or dwarf tree with modified canopy. The desired mango varieties are planted close to each other. The plant population will be nearly 700 trees/acre instead of the traditional plant population of 60 trees/acre.

Proper drip irrigation with fertigation facilities are required for maintaining the orchard. An amount of Rs.10.00 lakh/ha is set apart for establishing high density plantations of mango in Departmental farms. This amount can be utilised for land preparation,cost of planting materials,cost of other inputs,pruning requirements and all other expenses in connection with the establishment of high density plantations. These HDP plots should be established as demonstration units for farmers. An amount of Rs.30 lakh is set apart for establishing High Density Plantations of mango in Departmental farms. Suitable farms should be selected at district level and details communicated to this office.

General Instructions

- 1. Farm Officers should prepare additional forecast for this scheme or modify the existing forecast of expenditure as the case may be.
- 2. Farm Officers should assess the requirement of inputs and other items required for the production of targeted number of planting materials, well in advance.
- 3. Store purchase rules shall be strictly adhered to.
- 4. Tender/E-tender and other stipulated formalities shall be followed where ever necessary.

Monitoring

Deputy Director of Agriculture (YP) is in charge of the scheme at district level DDA(YP) should inspect all the farms in the district at least once in a month and monitor the activities of the scheme. The Principal Agricultural Officer of the district should monitor and review all the components of scheme in each month. It should be ensured that all the inputs are available in time for the production of quality planting materials, out put and outcome of the scheme, mode of implementation ,period of completion and the deliverables of the scheme should be closely monitored by the PAO. In case of erring officers, appropriate actions should be initiated/recommended to higher officials at state level.

Additional Director of Agriculture (Farms) will monitor the scheme at state level. The Principal Agricultural Officer should send weekly report of the programme to agrifarmsth@gmail.com. Monthly progress reports pertaining to the scheme should invariably contain component wise physical and financial targets and the stage of implementation of the programme should be brought to the notice of Additional Director of Agriculture (Farms) or Joint Director of

Agriculture (Farms) and get it cleared then and there itself. The scheme shall be implemented by abiding the terms and conditions stipulated in the Government Order cited as reference.

The expenditure towards the implementation of the scheme will be met from the amount earmarked for the scheme 'Development of Fruits' under the H/A 2401-00-119-79 Plan.
