Sub:- Annual Plan 2022-23 -Group insurance scheme to members of Karshika Karma Sena and Agro Service Centres and newly formed Krishi Sree centres under scheme "Support to Farm Mechanization"-Administrative Sanction accorded -Working Instructions - issued

Ref:- G.O. (Rt) No. 514/2022/AGRI dated 13/06/2022

Government of Kerala vide reference cited has accorded Administrative sanction for the implementation of the scheme "Support to Farm Mechanization" during 2022-23 for an amount of Rs. 1181.00 lakh under the H/A 2401-00-113-83 (P), where in an amount of Rs. 20.00 lakh is earmarked as state share of insurance premium for registered members of Karshika Karma Senas, Agro Service Centres/ Krishisree Centres in association with insurance companies

Objectives

To provide accidental insurance coverage to the members of the Agro Service Centres / Krishisree Centres and Karshika Karmasenas

Mode of Operation

Suitable policy will be worked out with Government Agencies like Kerala State Insurance Department, LIC, etc. Maximum state share of premium per personnel per annum will be limited to Rs. 500/- which can be met from the funds available under the scheme for which Rs. 20 lakh is set apart.

The Project Director, ATMA will prepare a detailed list of workers after scrutiny and submit the same to the Director of Agriculture. Insurance will be arranged from the Directorate of Agriculture.

Financial Outlay

In the financial year 2022-23, an amount of Rs. 20.00 lakh is earmarked as state share of insurance premium for registered members of Karshika Karma Senas, Agro Service Centres/ Krishisree Centres in association with insurance companies. 4000 numbers of registered members are proposed to be covered under this scheme with a total financial outlay of Rs.20.00 lakh.

The expenditure for the scheme will be met from the budget provision of Rs. 20 lakh set apart for 'Group insurance scheme to members of Karshika Karma Sena and Agro Service Centres and newly formed Krishisree centres' under H/A 2401-00-113-83 (P)
