Sub:- Agriculture Department – Establishment – Appointment to the post of Agricultural Assistant Grade. II on Rs. 10480-18300 (Revised) in Agriculture Department – Orders issued – regarding.

Read:- No. RIC(3) 16592/12/GW dated 19/01/2015 of the Secretary, Kerala Public Service Commission, Pattom, Thiruvananthapuram.

**Order No. SE (3) 50402/12 Dated: 13/04/2015.**

The candidates listed out in the Annexure is advised by Kerala Public Service Commission for appointment to the post of Agricultural Assistant Grade. II on the scale of pay of Rs. 10480-18300 in the Agriculture Department. They are appointed provisionally as Agricultural Assistant Grade. II and allotted to Principal Agricultural Officers noted in the Annexure. The concerned Principal Agricultural Officers will issue suitable posting orders.

The advice of the candidates are subject to Rule 3(c) of General Rules of the KS&SSR 1958.

The appointment is temporary under Rule 9(a)(1) of the General Rules as provided for Rule 10(b) of those rules.

The candidates should report for duty before the officers concerned within 15 days on receipt of the posting orders from the concerned Principal Agricultural Officer. The Principal Agricultural Officer shall issue posting orders to the candidates stipulating the above condition.

The candidates should produce the following documents while reporting for duty.

- a) Original Certificates to prove the date of birth and qualifications, etc.
- b) Certificate of physical fitness obtained from a Government Medical Officer not below the rank of Assistant Surgeon in Government Service as prescribed in G.O(P) No. 20/2011/P&ARD dated 30/06/2011.
- c) Prescribed Community certificate in original
- d) Non-Creamy Layer certificate in original

The candidates will fill up the three forms of attestation in the prescribed proforma enclosed (Annexure 1) and hand it over to the appointing authority at the time of joining duty for Police certification. The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission. For that purpose the appointing authority shall forward an attested copy of the relevant pages of Service Book of the incumbent to Kerala Public Service Commission as ordered in G.O(P) No. 20/2011/P&ARD dated 30/06/2011. The candidates will be placed on probation from the date of regularization of appointment for a period of 2 years of duty within a continuous period of 3 years. Application for correctness of date of birth if any required should be furnished within 5 years from the date of entry in service.

Concerned Principal Agricultural Officer is directed to submit the attested copies of first three pages of Service Book and Identification certificate to Kerala Public Service Commission, Thiruvananthapuram within a week.

The date of joining duty of the candidates will be reported to this office immediately after the candidates joining duty. In case a candidates does not join duty within the joining time allowed in the appointment order the details of that candidates should be reported to this office promptly.


