Secretary, Kerala Public Service Commission.

**ORDER NO. SD(1) 33427/2017 DATE: 03-02-2018**

The candidates noted in the annexure to this order are advised by Kerala Public Service Commission for appointment to the post of Agricultural Officer on Rs.39,500-83,000 in the department. They are appointed as Agricultural Officers in the Department and posted in the Krishi Bhavan noted against each shown in the Annexure.

The advice of the candidates are subject to Rule 3(C) of the General Rule of KS & SSR 1958. The appointment is temporary under Rule 9(a) 1 of General Rules as provided under Rule 10 of these rules.

The candidates should report for duty before the Principal Agricultural Officers concerned within 15 days on receipt of this order. The candidates should produce a medical certificate obtained from a Medical Officer not below the rank of a Civil Surgeon as prescribed in GO(P) No.20/2011/P&ARD dated 30/06/2011 and original certificates to prove date of birth, qualification, community and recent passport size photographs at the time of joining duty. The Principal Agricultural Officers will verify the original certificate with reference to the details shown in advice letter of Kerala Public Service Commission.

As Ordered in GO(Ms) No.170/74/PD dated 18/07/1974, the appointing authority has to obtain the necessary details of the candidate duly filled up in the prescribed proforma and to make necessary arrangement for verification of character and antecedents of the candidates. But before the character and antecedents of the candidates are verified, the appointing authority may appoint the candidate mentioned in his/her letter temporarily under clause (1) of sub rule (a) of Rule 9 of the General Rules as provided in Rule 10 (b) of those rules vide GO (P) No 49/74/PD dated 05/03/1974.

The appointing authority should satisfy himself about the identity and signature of the candidate before he is allowed to join duty. For this purpose, a copy of One Time Verification Certificate which includes the scanned image of photo and signature of the candidate is enclosed herewith after noting their in his/her serial number in this order. The photograph and signature of the candidates may be verified and facts may be recorded by the appointing authority in the original One Time Verification Certificate itself. If there is any discrepancy, the candidate should not be allowed to join duty and fact should be reported to this office forthwith. After the candidate is allowed to join duty the original One Time Verification Certificate shall be communicated to this office.

The Principal Agricultural Officers should verify the Non Creamy Layer certificate of the candidates with serial Nos. 1, 4, 6, 8 and Community Certificate of the candidate with serial No. 2 at the time of joining duty. The copy of One Time Verification Certificate and Community Certificate is enclosed.

The candidates will be placed on probation for a period of 2 years on duty within a continuous period of 3 years from the date of regularization of appointment. He/she should pass Account Test (Lower) examination during the Probation period. Orders regularizing their temporary appointment/placing them on probation will be issued soon on receipt of Police Verification Report.

Application for correction of date of birth, if any should be submitted by the candidate within 5 Years of their date of entry in service as stipulated in G O(P) No. 46/91/P&ARD dated: 30-12-1991.

The Principal Agricultural Officers will forward a detailed report on the date of joining duty of the candidates/verification of other factor mentioned above to this office immediately after the candidates join duty. In case, a candidate does not join duty within the time limit allowed, the details of that candidates along with the identification certificates should also be forwarded to this office promptly.

Since the selection to the post is made from a common select list, the candidates are informed that in the event of discharge from service for want of vacancies, they may either re-register their names in the office of the Kerala Public Service Commission from where they were advised and get themselves re-appointed on further advice of Kerala Public Service Commission or they may wait for their turns for re-appointment to the post in the Department, in case they desire to continue as probationers in the post from which they are discharged vide circular memorandum No. 3737/Rules 1/90/P&ARD dated: 29-03-1990 and G O(P) No. 7/91/P&ARD dated: 15-02-1991.
