ORDER

As per the Government orders 1st, 2nd, 3rd and 4th cited, funds under General, SCP & TSP components were released to the implementing agencies for implementing the sanctioned projects during the financial year 2021-22. As per reference 6th cited, Government have also accorded administrative sanction for implementing the new projects and revalidated projects during the year 2022-23.

2. As per the letter read as 7th paper above, Mission Director, State Horticulture Mission has requested to reallocate the unspent RKVY- SCP funds of Rs.105.41 lakhs available with them to the needy projects of other implementing

agencies. As per reference 15th cited Managing Director, MILMA has also surrendered the RKVY-SCP funds of Rs.173.01 lakhs & RKVY-TSP funds of Rs.88.33 lakhs released for the project "Tetra Brik Packing System at Malayora Dairy" as they were not able to finalize the purchase procedures for the items in the project.
