The tender is to be submitted as e-tenders through <https://etenders.kerala.gov.in>. Since this is an e-tender, only those bidders who have enrolled in the above portal with their own digital signature certificate (DSC) can participate in the tender. e-Tender document and other details can be obtained from the above e-portal. The bidders should be able to supply all the items of the e-tender for which he has participated.

Bidders will be directed to the payment gateway page of the State Bank of India. There are two options – (1) State Bank of India (SBI Net banking payment) and (2) Payment through NEFT from other banks to the payment gateway of SBI.

For obtaining **digital signature certificate** (DSC) and necessary portal enrolment bidders can visit the website <https://etenders.kerala.gov.in/>

The e-tenders submitted by the competent dealer/supplier should definitely contain a scanned and signed copy of the *Compliance Statement for Procurement of Filter Paper in Annexure-II. The originals of all the documents except BOQ should be submitted directly to this office before the last date of receipt of the e-tender.*

Tenders will be opened in the online presence of such bidders or their authorized representatives who have logged in at the prescribed time of opening bids. If the date fixed for opening happens to be a holiday/ due to net failure the tenders will be opened in the next working day, at the same time.

The price of the e-tender form shall be received only through online payment -SBI / NEFT from other banks.

Scanned copy of the agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/-** should be submitted online and original to the undersigned before the opening of the e-tender.

The cost should be quoted in Indian currency only.

The Purchase Committee headed by The Additional Director of Agriculture (Planning) will scrutinize the tenders received and finalize suitably. The decision of the Director of Agriculture Development and Farmer's Welfare Department will be final for the award of the contract.
