ORDER

As per letter read as 1st paper above, the Director of Agriculture has forwarded the proposal worth ₹ 100.00 Lakh submitted by the Managing Director, Kerala State Warehousing Corporation for "Assistance to Kerala State Warehousing Corporation - Construction of Godown cum Agriculture Complex" and informed that ₹ 100.00 lakh has been earmarked for the project in the Annual Plan under the Head of Account 4408-02-101-98 Plan.

2. The Director of Agriculture has requested to place the proposal in the working group for according administrative sanction for the release of the budgeted

amount of Rs.100,00,000 (Rs. Hundred lakh only) to the Managing Director, Kerala State Warehousing Corporation for "Assistance to Kerala State Warehousing Corporation-Construction of Godown cum Agriculture Complex" under the head of account 4408-02-101-98 Plan from the current year's budget provision. He has also informed that the project will be managed by the Managing Director, Kerala State Warehousing Corporation and project implementation is expected to be completed by 31-03-2023.

3. The Working Group Meeting held on 21/11/2022 has approved the scheme for "Assistance to Kerala State Warehousing Corporation-Construction of Godown cum Agriculture Complex" for an amount of ₹ 100 lakh.

4. In this circumstances, Government are pleased to accord Administrative Sanction for the scheme "Assistance to Kerala State Warehousing Corporation-Construction of Godown cum Agriculture Complex" for an amount of ₹ 100,00,000 (Rs. Hundred lakh only) under the head of account 4408-02-101-98 Plan. The Scheme will be managed by the Managing Director, Kerala State Warehousing Corporation and should be completed by 31.03.2023.

5. The expenditure in this regard will be met from the head of account 4408-02-101-98 Plan. The Director of Agriculture will draw and disburse the amount to the Managing Director, Kerala State Warehousing Corporation subject to the following conditions:-

- 1) All rules, formalities and procedures shall be strictly followed for the implementation of the scheme. The norms of financial propriety shall be adhered to.
- 2) The expenditure would be met only from the provision available under the appropriate head of account.
- 3) The fund release will be based on actual requirement, and the fund released should not be parked in banks.
- 4) Store Purchase Rules shall be strictly adhered to for all kinds of purchases.
- 5) Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- 6) Post creation and purchase of vehicles are not admissible under the scheme.
- 7) The Head of Departments shall monitor the implementation of the scheme and ensure that the implementation is as per the existing procedures, rules and regulations.

8) The implementation agencies/ Departments also should prepare an implementation schedule to complete the project in time and send regular progress report on financial and physical progress on a quarterly basis.

9) The Director should hold monitoring meetings to review the progress and send report to Government regarding the progress of implementation of the approved scheme.

10) The Director of Agriculture shall sign an MoU with the concerned implementing agencies of the scheme before releasing the funds. It should also be ensured that the Utilization Certificates pertain to all schemes are submitted by the agencies in time.

11) Plan review will be conducted on every month.
