ORDER

As per the G.O read above, Government have accorded Administrative sanction for the implementation of the Coconut Development Board Schemes like Laying out of Demonstration plots, Organic Manure Unit and Replanting and Rejuvenation of old coconut Gardens for an amount of Rs. 216.58 lakhs (Rupees Two crores sixteen lakhs fifty eight thousand only).

2) In addition to the above amount, as per letter read as second paper above, Coconut Development Board requested a new administrative approval for an amount of Rs. 170.05 lakhs to implement 910 Ha of LoDP (Laying out of Demonstration Plots) and 144 numbers of OMU (Organic Manure Unit) in the districts of Alappuzha, Kozhikkode, Malappuram and Kannur as follows:-

- 2) As per the letter read as 3rd paper above, the Director of Agriculture has requested to accord Administrative Sanction for the implementation of the above mentioned schemes for an amount of Rs. 170.05 lakhs to implement 910 Ha of LoDP (Laying out of Demonstration Plots) and 144 numbers of OMU (Organic Manure Unit) in the districts of Alappuzha, Kozhikkode , Malappuram and Kannur with 100 % CSS (Centrally Sponsored Schemes) during 2022-23.
- 3) Since it is 100 % centrally assisted project, Government are pleased to accord Administrative Sanction for the implementation of the above said components sanctioned by the Coconut Development Board for an amount of Rs. 170.05 lakhs to implement 910 Ha of LoDP (Laying out of Demonstration Plots) and 144 numbers of OMU (Organic Manure Unit) in the districts of Alappuzha, Kozhikkode , Malappuram and Kannur with 100 % CSS (Centrally Sponsored Schemes) during 2022-23 through PFMS guidelines in addition to the Administrative sanction issued as per the GO read above..
