ORDER

As per the Government Order read as 1 st paper above the Agricultural Insurance Company of India Limited(AICIL) has been selected as the implementing agency of both Pradhan Mantri Fasal Bima Yojana(PMFBY) and Restructured Weather Based Crop Insurance Scheme(RWBCIS) in Kerala for Kharif 2022 season and as per Government Order read as 2 nd paper above, sanction has been accorded to release an amount of Rs 8,04,92,569/- as first instalment of state share of premium subsidy to Agricultural Insurance Company of India Limited towards PMFBY & RWBCIS for kharif 2022.

plan under the scheme PMFBY- RWBCIS.

As per the Government Order read as 4 th paper above authorisation has been given for additional expenditure to the tune of Rs 21,24,11,000 /- under the Head of Account 2401-109-65-02 for meeting the entire requirement of second instalment of state share of premium subsidy to the Agriculture Insurance Company of India Ltd(AICIL) for K harif 2022 under the scheme Pradhan Mantri Fasal Bima Yojana and Restructured Weather Based Crop Insurance Scheme.

Having examined the matter in detail, Government are pleased to accord sanction to release Rs. 21,24,10,985(Twenty one crores twenty four lakes ten thousand nine hundred and eighty five only) for meeting the second instalment to the Agriculture Insurance Company of India Ltd(AICIL) for kharif 2022 in the scheme PMFBY-RWBCIS, 2022-23 under the head of account 2401-00-109-65-02 (plan voted) during the current financial year.
