#### ORDER

As per Government order read as 3rd paper above, the first installment of funds for an amount of ₹ 7114.65 Lakhs under the scheme Sub Mission on Agricultural Mechanization (SMAM) 2022-2023 for the categories General, SCP and TSP, inclusive of State share, has been released through the new procedure of fund flow based on SNA system in PFMS.

- 2. Government of India as per the letter read as 4th paper above has released a total amount of ₹4268.79 Lakhs (₹3168.79 Lakhs General category + ₹400.00 Lakhs TSP category + ₹700.00 lakhs SCP category) for implementation in 60:40 sharing pattern. The Central share of the second installment released is intended to continue the activities approved in the Annual Action Plan for ₹28402.59750 lakhs .
- 3. Accordingly the Director of Agriculture as per the letter read as 5th paper above has requested sanction to release the second installment amounting

- to ₹ 7114.66 lakhs (Rupees Seventy One crores fourteen lakhs and sixty six thousand only). As the budget provision available is highly insufficient and since the entire amount is essential for drawl and credit of the amount to SNA account mapped in PFMS, as per the request of Director of Agriculture, reappropriation has been agreed to the tune of ₹62,92,64,000/- as per the Government Order read as 6th paper above.
- 4. Government have examined the matter in detail and are pleased to accord sanction to the Director of Agriculture to release the *second installment amount* of ₹. 7114.66 lakhs (Rupees Seventy One crores fourteen lakhs and sixty six thousand only) under the heads of account as detailed in the table below, through the EAT module of the revised PFMS system, for the implementation of the scheme Sub Mission on Agricultural Mechanization (SMAM) during 2022-23:

- 5. The Director of Agriculture Development and Farmers' Welfare is authorized to draw and disburse the amount for the purpose subject to the condition that the amount earmarked for SCP and TSP components will be spent exclusively for the respective category of beneficiaries.
- 6. The Director of Agriculture Development and Farmers' Welfare after completion of the financial year should prepare a reconciled Statement of Expenditure (SoE) and furnish the same to Accountant General (Audit) as stipulated in Government Order and Circular read as 1st and 2nd paper above.
