#### **CIRCULAR**

Sub:- Development of Fruit, Flowers & Medicinal Plants – Distribution of Fruit Plants 2023-24 - Administrative Sanction accorded – Working Instructions issued – reg.

Ref:- 1) G.O.(Rt) No.545/2023/AGRI Dated 05/06/2023 Thiruvananthapuram

Instructions for the implementation of the scheme component entitled - Distribution of fruit plants under the scheme - Development of Fruits, Flowers and Medicinal Plants with the Head of Account **2401-00-119-79** (P) is hereby issued for compliance at all levels and speedy implementation.

Government of Kerala have approved the scheme for an outlay of ₹ 1467.00 lakh for implementing this component under the scheme as per reference (1) of this circular. Hence the working instructions for compliance at all levels.

Fruit plant distribution is one of the main flagship programmes of the Government and earnest steps shall be taken to implement the same for achieving the desired results of the scheme in achieving self sufficiency in fruit production and improving consumption.

The Scheme is also important in the light of the current initiatives by the Department on value addition and processing.

#### 1. Procurement and Distribution of fruit plants

- (a). There is no restriction on the type of beneficiary. Farmers, general public, public & private institutions, organizations, Farmer Interest Groups (FIGs) like Krishikoottams, NGOs, Residents Associations etc., can avail the benefit of the programme.
- (b). No applications shall be collected for the scheme. However, register containing the details of distribution with address of the beneficiary shall be maintained. In the case of bulk distribution to the farmer groups, Krishikoottams, Institutions etc., a distribution statement duly attested by the distributor and certificate to this effect by the Agricultural Assistants / AAOs shall be maintained.
- (c). The field level planting shall be ensured and followed up by the Agricultural Assistants of the locality.
- (d). Varietal tags for the fruit plants are mandatory. The officer who procure the same and distribute shall assure the quality of the planting materials. The procurement can be done from Departmental Farms, Kerala Agricultural University, VFPCK, KSAMM, Aralam Farming Corporation (for distribution to Kozhikkode, Wayanad, Kannur and Kasaragod Districts) and Kudumbasree. The procurement and distribution targets for the year 2023-24 are given as Table 1.

The Principal Agricultural Officers shall allocate the procurement and distribution targets to the sub offices at Block and Panchayat level. The cost of the planting material thus distributed shall be credited to the respective suppliers from the Head of Account 2401-00-119-79 (P).

- (e). The planting materials shall be distributed as per the following rates:
  - Grafts/ layers @ 75% subsidy (25% beneficiary contribution)
  - Seedlings will be issued free of cost (100% subsidy)
  - Tissue cultured banana plantlets @ Rs.5 per hardened plant (₹ 15 as subsidy)

No direct cash subsidy to farmers is allowed under this scheme.

- (f). Necessary receipts for collecting the beneficiary contribution shall be put in place. PAOs shall arrange sufficient copies of the receipt books for collecting the beneficiary contribution for agencies outside the Department. The procedure for collecting the money through TR5 receipts shall be followed wherever the remittance is to be made in to the Government account. Necessary entries in this regard shall also be carried out in the cash book and timely remittance shall be done. Inordinate delay is to be strictly avoided.
- (g). The planting materials available at Departmental Farms shall be given preference while procurement. Only the cost of the planting materials shall be given to farms. The cost of production of them shall be met from the appropriate component under the scheme -'Production & Distribution of Planting materials' 2401-00-104-91 (P).

#### (h). All activities of distribution shall be completed before December, 2023.

- (i). All Principal Agricultural Officers shall submit the action plan for distribution of fruit plants distribution before 30/06/2023 to the undersigned.
- (j). Cost of transportation of planting materials can be met from this scheme. An amount of ₹ 77.81361 Lakh is allotted to the districts as per the Table 2. Necessary store purchase rules are to be observed while hiring the vehicles for transport. The cost of transportation shall be admissible to farms also.
- (k). The project Cherthala Mandalam Scheme submitted by PAO, Alappuzha, SPC-Madhuravanam project submitted by PAO, Kasaragod and the sapling distribution to Rotary Club in Idukki, Ernakulam, Thrissur and Palakkad district is inclusive in the alloted targets.
  - (1). The loading/unloading charges shall be met from the LSGD fund.
- (m). Agencies shall be responsible to replace all the damaged planting materials during transportation and delivery. Agencies shall not demand payment for the replaced planting materials and any damage to the distributed planting materials should be intimated to the agencies within three days.

## **Duties of designated officials of the Department**

## 1. Additional Director of Agriculture (Farms, Biogas & Vegetable)

The Additional Director of Agriculture (Farms & Vegetable) is the project manager. State level co-ordination of all districts & review of fruit plant seedlings produced by the agencies/Department shall be done by the Additional Director of Agriculture (Farms & Vegetable). Monitoring, reviewing, district level distribution of fruit plants and state level coordination of all districts shall be done by the Additional Director of Agriculture (Farms & Vegetable).

#### 2. Principal Agricultural Officer

- a. All the activities related to the scheme shall be co-ordinated and monitored.
- b. PAO shall delegate the duties to monitor the scheme to Deputy Director being the nodal officer of the block.
- c. Directions shall be given to DDA(H) to prepare the plan regarding the distribution of fruit planting materials at Krishi Bhavan level as per the physical target allotted to districts.
- d. Transportation of fruit plant seedlings from the production unit to the Krishi Bhavan shall be arranged as per the allotted targets. Vehicles from departmental farms, engineering section or that vehicles rented for distribution of fruit plants can be utilized for procurement and distribution of fruit plants. Vehicles of Agro Service Centres, Karshika Karmasena, VFPCK also can be utilized. An office assistant shall accompany the vehicle and also assign the duty to receive the planting material from the production unit and distribute the same to the Krishi Bhavan with receipt.

#### 3. Deputy Director of Agriculture (Horticulture

- a. Make arrangement of vehicle for transportation of fruit plants.
- b. Co-ordinating the activities for the timely supply of planting material.
- c. Krishi Bhavan level calendar shall be prepared regards the distribution of fruit plants for the district. Weekly status report regards the distribution of fruit plants shall be submitted.
- d. Krishi Bhavan level documentation of the scheme from the beginning shall be submitted to Directorate.
- e. All formats of reports related to scheme shall be updated on stipulated time.
- f. An action plan regarding the month of supply of planting material variety wise shall be prepared based on the report of DDA(YP) and other agencies.
- g. Statement showing the consolidated report of remittance details (receipt no., date, amount, nos.) to the agencies shall be informed to the agencies in written.

#### 4. Deputy Director of Agriculture (YP)

- a. Collection of data of planting material from departmental farms and consolidated at district level and submit the district plan to Director.
- b. Direct monitoring of planting material production at the departmental farms.
- c. District level ready to issue planting material details shall be informed to DDA(H).
- d. To co-ordinate the production protocol and to ensure the quality of planting materials produced by VFPCK, Kerala Agricultural University, KSAMM, Kudumbasree and Aralam Farming Corporation.

#### 5. Assistant Director of Agriculture

- a. All activities related to the scheme at the block level shall be monitored by ADA.
- b. All of the physical targets to the Krishi Bhavan and the details of requirement of planting material at Krishi Bhavan level shall be consolidated and submitted to the PAO office on time.
- c. Consolidated weekly report of distribution of planting materials at block level shall be submitted to PAO.
- d. Statement showing the detailed of fruit plants(no. & amount) shall be submitted to

the agencies monthly on time.

e. Quality of seedlings produced from VFPCK, Kerala Agricultural University, KSAMM, Kudumbasree, Aralam Farming Corporation shall be ensured.

#### 6. Agricultural Officers

- a. Agricultural Officers shall be responsible for the distribution of fruit plants at Grama Panchayath level.
- b. The fruit plants distributed to households, public places shall be kept updated and maintained in the appropriate registers.
- c. The scheme shall be implemented in co-ordination with the "Njangalum Krishiyilekku" programme.
- d. All beneficiaries/institutions of the scheme shall be registered in AIMS Portal.
- e. The fruit plants distributed to public places, roadsides, Government building premises, schools, tourist centres shall be planted in suitable areas in concurrence with LSGD institutions volunteers, MGNREGS, Krishikottam etc.
- f. The detailed information of the scheme shall be intimated to the Agriculture Development Committee.
- g. Weekly report of distribution of fruit plants shall be submitted to ADA.
- h. Training shall be arranged to Kudumbasree for production of planting materials and farmers after care of fruit plants respectively.
- i. Necessary entries in the stock register regarding the fruit plants received from different agencies by the Agricultural Officers shall be monitored and evaluated.
- j. Photographs with GPS co-ordinates and relevant details shall be documented without fail.

#### 7. Agricultural Assistants

- a. Necessary entries shall be made in the stock register and distribution register regarding the districts of fruit plants from various agencies.
- b. The fruit plants distributed at Krishi Bhavan from various agencies shall be intimated and distributed to the farmers of all wards on time and it shall be updated & documented in the appropriate register.

- c. Monitoring and documentation of fruit plants distributed and planted at the wards shall be done by the concerned Agricultural Assistant.
- d. Details of all beneficiaries of the scheme shall be maintained in the distribution register.
- e. Photographs with GPS co-ordinates and relevant details shall be documented without fail.

#### Scheme implementation and monitoring

- (a). The Project Manager of the scheme is Additional Director of Agriculture (Farms & Vegetable). The scheme is to be administered at district level by the Principal Agricultural Officers and monitoring shall be done by the Deputy Director of Agriculture (Horticulture). The Block level Assistant Directors of Agriculture are the implementing officers.
- (b). The Agricultural Officers and AFOs shall prepare suitable claims duly certified and submitted to the ADAs for effecting payments. The Agricultural Assistants shall be responsible for implementing the scheme components in their jurisdiction.
- (c). Regular follow up activities shall be carried out by the Agricultural Assistants and data collection including the area covered, expected production, final production etc., are also to be done. Proper orders in this regard shall be issued by the AOs / AFOs.
- (d). The Deputy Director (H) is hereby directed to conduct concurrent evaluation of the scheme including the details of implementation of the scheme, monthly progress reports and other statistics related to the impacts of the scheme. The duty of report preparation shall rest with Deputy Director (H) only and hence reporting formats and other schedules are to be kept ready and send for approval by the undersigned without any delay.
- (e). Prompt verification and inspections by the controlling officers to be carried out frequently and a report of inspections shall be furnished by the PAOs every month to the undersigned with recommendation of actions to be initiated in the case of any violations.
- (f). All rules, codes and manuals and procedures are to be followed wherever necessary.
- (g). This circular is issued for implementing the scheme components for 2023-24 only.

#### **Project management & duration**

The project will be managed by the Additional Director of Agriculture (Farms & Vegetables) at the Directorate of Agriculture. Project implementation is to be completed by 31/03/2024.
