CIRCULAR

Sub:- Annual Plan 2023-24-Scheme "Coconut Development"- Keragramam 2nd yr and Keragramam 3rd yr assistance -working instructions -issued -reg

Ref:- G.O(Rt)no.464/2023/AGRI dated 17/5/2023

In the Annual Plan 2023-24, a budget provision of Rs. 6895.00 lakh is earmarked for the scheme Coconut Development under the Head of Account 2401-00-103-87 Plan. The Administrative sanction for the implementation of second year and third year keragramams has been obtained as per the above reference, for which an assistance of Rs. 1288.00 lakh has been provided.

Objectives:

- 1. To support the Integrated nutrient, Pest and Disease Management (INM, IPDM) for the Keragramams established during 2022-23.
- 2.To support INM for Keragramams established during 2021-22.

Programme and activities envisaged:

1. Second year Keragramam:

Under this component, 98 Keragramams established during 2022-23 will be provided assistance at the rate of Rs.8.00 lakh per Keragramam for carrying out the activities of INM and IPDM in 100 Ha area.

The INM and IPDM activities shown above can be carried out in the keragramam wherein the most critical activity for productivity improvement shall be given priority for implementation as per the local needs. However, the state plan share will be limited to 8.0 lakh per Keragramam. The expenditure for this component is met from the head of Account 2401-00-103-87-34 OC Plan.

2. Third year Keragramam:

Under this component, 84 Keragramams implemented during 2021-22 is provided third year assistance @ 6.0 lakh per Keragramam for carrying out INM activities as per local needs in an area of 250 Ha and a total amount of Rs 504.00 lakh is earmarked for 84 keragramams the assistance is provided for the following activities.

The expenditure for this component is met from the head of Account 2401-00-103-87-34 OC Plan.

General Guidelines for scheme implementation:

- 1.The activities selected for implementation shall be soil test based approach especially with respect to soil pH.
- 2.Farmers are eligible for assistance during three years under Keragramam. If sufficient beneficiaries are not available for second year and third year assistance under Keragramam, a new beneficiary may be selected by Agricultural Officers after ensuring that such farmers have followed scientific management practices during previous years.

- 3.Store purchase rules should be strictly adhered to for all kinds of purchases. Tender/ etender and other stipulated formalities should be followed wherever applicable.
- 4. A visit schedule of Agricultural Assistants is to be prepared to ensure regular field visits to the keragramam areas.

The following general conditions should also be followed wherever applicable while implementing the scheme.

- 1.All rules, formalities and procedures shall be strictly followed for the implementation of the schemes. The norms of financial propriety shall be adhered to.
- 2. The expenditure would be met only from the provision available under the appropriate head of account.
- 3. The fund released will be based on actual requirement and the fund released should not be parked in banks.
- 4. Store purchase Rules shall be strictly adhered to for all kinds of purchases.
- 5. Tender/ e tender and other stipulated formalities shall be followed wherever necessary.
- 6. Post creation and purchase of vehicles are not admissible under the scheme.
- 7. The Heads of Departments shall monitor the implementation of the scheme and ensure that the implementation is as per the existing procedures, rules and regulations.
- 8. The implementation agencies / Department also shall prepare an implementation schedule to complete the project in time and send the regular progress report on financial and physical progress on a quarterly basis.
- 9. The Director shall hold monitoring meetings to review the progress and send report to Government regarding the progress of implementation of the approved scheme.
- 10. The Director, Agriculture / Director of Soil survey and Soil conservation Department shall sign an MOU with the concerned implementing agencies of the scheme before releasing the funds. It shall also be ensured that the Utilization certificates pertaining to all schemes are submitted by the agencies in time.
- 11. AIMS portal registration for all plan schemes and Digital Soil Health card is mandatory.
- 12.Geo fencing and Geo tagging is mandatory. It shall be ensured in every scheme wherever beneficiaries exist.
- 13.Plan Review will be conducted on every month.

Monitoring:

The Agricultural Officer of Krishi Bhavans will be responsible for effective implementation of the keragramam 2nd yrand 3rd yr at Panchayat level. The Assistant

Director of Agriculture will monitor the scheme at block level and Deputy Director of Agriculture (YP) at district level. Principal Agricultural Officer will supervise the scheme implementation at district level and Additional Director of Agriculture (CP) will monitor the scheme at State level.

District wise physical and financial target for second year Keragramam, third year Keragramam is appended as Annexure 1 & 2. The ADAs should submit a consolidated block wise progress report to the DDA (YP) who in turn will submit a detailed report in Annexure-3 (second year assistance), Annexure-4 (Third year assistance) to the Additional Director of Agriculture (CP) by 5 th of every month. (Reporting and official correspondence in respect of this scheme may be made in the email -id adatbagridir@gmail.com). The Principal Agricultural Officers shall furnish a detailed completion report including the no. of beneficiaries (male, female, SC/ST, general) and utilization certificate in proper format (Annexure 5, 6) immediately on completion of the project.
