CC 1:2:4,20mm bs top wearing coat of thickness 7.5cm is also provided side of DR masonry pointing at a height 0.75m with Cm 1:3 cement mortar and ramp also provided. Second part includes construction of VCB and leading channel reconstructed of 75m length. The VCB base and and height of VCB is 1.60m .its foundation has 70cm depth from the base of thode. The foundation contains 3 layers. First layer DR masonry 30cm depth, third layer CC 1:2:4 20mm broken stone of 20cm thick 1:1.5:3 RCC base of 20cm thick, abuttment is 50cm thick and 1.60m hight provided thambakam wood shutter.
