The Director, Department of Agriculture Development & Farmers' Welfare, as per the letter read as 7th paper above, has informed that during the year ended 31st March, 2023, an amount of ₹2,24,98,815/- was resumed from the PSTSB A/c No.799012700000595 of the Construction Engineer, Kerala Land Development Corporation, Alapuzha, of which ₹1,23,89,937/- pertains to the project Risk Management Package - Infrastructural Development works of various Padasekharams in Kariland of Purakkad area in Alappuzha District under the Annual Plan Scheme 2022-23 - Development of Agriculture Sector in Kuttanad released from the H/a 2401-00-119-78 Plan vide proceedings read as 2nd to 4th papers above. Based on the letter from the MD, KLDC, the Director, Department of Agriculture Development & Farmers Welfare has requested Government to release an amount of ₹1,23,89,937/- which was resumed from the PSTSB A/c No.799012700000595 during the FY 2022-23.
