Bidders will be directed to the payment gateway page of the State Bank of India. There are two options – (1) State bank of India (SBI Net banking payment) and (2) Payment through NEFT from other banks to the payment gateway of SBI.

For obtaining **digital signature certificate** (DSC) and necessary portal enrolment bidders can visit the website <https://etenders.kerala.gov.in/>

Tenders will be opened online. The bidders or their authorized representatives can log in at the prescribed time of opening bids. If the date fixed for opening happens to be a holiday/ due to net failure the tenders will be opened in the next working day, at the same time.

The price of the e-tender form shall be received only through online payment -SBI/ NEFT from other banks.

Scanned copy of the agreement in the prescribed format in Kerala Stamp paper worth **Rs. 200/-** should be submitted online and original to the undersigned before the opening of the e-tender.

The cost should be quoted in Indian currency only.
